

The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on April 17, 2024, at 3:00 p.m., to consider the following: Tentative Parcel Map P20-0003/Jones submitted by KEVIN MCBRIDE (Agent: Lebeck Engineering, Inc.) to subdivide a developed 4.52-acre parcel, with two (2) existing residential units, into two (2) parcels of 2.20 acres (Parcel 1) and 2.32 acres (Parcel 2) in size. The property, identified by Assessor's Parcel Number 070-160-001, consisting of 4.52 acres, is located on the east side of Sierrama Court, approximately 700 feet east of the intersection with Sierrama Drive, in the Shingle Springs area, Supervisorial District 4.
