RE: Update on Redistricting Process

The purpose of this memo is to provide the Board of Supervisors an update on the Redistricting process and to request direction on setting a schedule for the remainder of the process.

On March 15, 2011, the Board of Supervisors provided direction on the process for Redistricting in 2011, as follows:

- 1) Surveyor analyses new Census data and develops 3 to 6 proposed alternative maps
- 2) In April, Surveyor previews map alternatives to Board of Supervisors
- 3) In May, hold at least three well-advertised public forums to receive comments
- 4) In June, Board of supervisors holds first formal public hearing on map alternatives
- 5) In July, board of supervisors holds second public hearing where a map alternative is adopted via ordinance.

In May, six formal public forums were held (as listed on attached schedule) to receive comments from community members. Individuals were encouraged to submit their written comments on the proposed alternative maps. In addition to the formal public forums, staff presented the maps to several other groups at the invitation of the group. The maps were also posted on the County website and community members could submit comments via email. All of the written comments and a summary key spreadsheet are available for your review and consideration.

The next step is for the Board to hold its first public hearing in preparation for the adoption of the final redistricted map. The proposed schedule for those meetings is as follows:

June 27, 2011 Monday 9:00am – all day Board Chambers	First public hearing to receive comments from the public and select one or two alternative maps for final consideration. Direct staff to adjust maps, as desired.
July 18, 2011 Monday 9:00am – all day Board Chambers	If necessary, continuation of July 27 hearing to further consider remaining alternatives and select final map for adoption.
July 26, 2011 Tuesday Board Chambers	First reading of the ordinance to adopt final map.
August 2, 2011 Tuesday Board Chambers	Second reading of the ordinance to adopt final map.

Recommended action today:

- 1) Receive comments gathered at public forums and via the redistricting website.
- 2) Direct staff to schedule meetings to select final district map, as outlined above.
