Dear El Dorado County Supervisors,

In fairness to your constituents across El Dorado County whom you have a duty serve, please remove item #2 pertaining to 515 & 525 Main Street, Placerville from the consent calendar, and do not proceed with action item #28. The fate of these historic buildings needs to be the outcome of a transparent and genuine public process. They are part of a nationally significant historic district that represents the Gold Mining Period (1848-1942), from the discovery of gold in California to the end of non-essential gold mining in support of WWII under President Franklin D. Roosevelt .

1) By transferring these properties to the City of Placerville, the County would knowingly put them on a path that is aimed at destroying the historic integrity of the buildings, and the historic district they are a part of.

The City of Placerville and the El Dorado County Arts Council (aka Arts and Culture El Dorado) have been engaged in private collaboration to develop a "Master Plan" for these and other historic buildings without meaningful public involvement.

The City of Placerville has a track record of destroying historic assets:

- a. it demolished the 1861 Ivy House where the Ivy House Archaeological Site still remains
- b. it condemned the 1855 Herrick Building which was restored by intervening citizens and the help of the state Office of Historic Preservation
- b. it plans to destroy the historic context of the 1926 Druid Monument, remove it from its historic location, and destroy an associated 1926 bridge and remnant of the Lincoln Highway historic streetscape

- c. based on the work of City staff, the City's planning commission approved demolition of a 1899-1939 historic house in a residential historic district that is associated with the history of the timber industry
- d. it failed to properly survey the Upper Broadway project area for archaeological resources which almost caused the destruction of a major Native American site last week

2) The County has an obligation to hear public comment before making this decision. As the current owner of these significant historic assets, the County has a critical role in ensuring their stewardship.

The Board of Supervisors and its constituents should be fully informed about these resources before any decisions are made.

Please review the attached Primary Record forms for 515 & 525 Main Street were developed by a historian / consultant who completed an initial survey of the Placerville Historic District for the Friends of Historic Hangtown. Also attached is a map of the Placerville Historic District proposed in 2012 by a Historical Advisory Committee which the City has inactivated.



This Art Deco Post Office was designed by architect Louis A. Simon and built by the Federal Works Department. Built of reinforced concrete, the one-story building has five bays and a hip roof. Entry is via double glass and frame doors, accessed by concrete stairs from the sidewalk, and protected by a projecting canopy. Art Deco grille work and a golden eagle are located above the entry doors. Two windows, behind decorative Art Deco grilles, flank the entry on each side and are set in recessed panels; they continue along the side elevations.





This simple Art Deco building has a rectangular mass and a flat roof. The building is constructed of reinforced concrete. The primary façade features three traditional flat pilasters separating a fixed tripartite window and a recessed doorway. Fenestration on the side elevations consists of 2/2 light frame sash windows, double-hung.

the City of Placerville and Arts Council unimaginative “Master Plan” to turn the Confidence and Jane buildings into “APARTMENTS” and the Post Office Building into a “DANCE HALL”. The Arts Council proposal does not maximize use and exposure / happiness. On Thursday, April 16, 2020, the City was going to turn Placervilles Ancient Wopumnes Tribe Grinding Rock Village site into a “DRIVEWAY”.







Dear El Dorado County Supervisors,

In fairness to your constituents across El Dorado County whom you have a duty serve, please remove item #2 pertaining to 515 & 525 Main Street, Placerville from the consent calendar, and do not proceed with action item #28. The fate of these historic buildings needs to be the outcome of a transparent and genuine public process. They are part of a nationally significant historic district that represents the Gold Mining Period (1848-1942), from the discovery of gold in California to the end of non-essential gold mining in support of WWII under President Franklin D. Roosevelt .

1) By transferring these properties to the City of Placerville, the County would knowingly put them on a path that is aimed at destroying the historic integrity of the buildings, and the historic district they are a part of.

The City of Placerville and the El Dorado County Arts Council (aka Arts and Culture El Dorado) have been engaged in private collaboration to develop a "Master Plan" for these and other historic buildings without meaningful public involvement.

The City of Placerville has a track record of destroying historic assets:

- a. it demolished the 1861 Ivy House where the Ivy House Archaeological Site still remains
- b. it condemned the 1855 Herrick Building which was restored by intervening citizens and the help of the state Office of Historic Preservation
- b. it plans to destroy the historic context of the 1926 Druid Monument, remove it from its historic location, and destroy an associated 1926 bridge and remnant of the Lincoln Highway historic streetscape

- c. based on the work of City staff, the City's planning commission approved demolition of a 1899-1939 historic house in a residential historic district that is associated with the history of the timber industry
- d. it failed to properly survey the Upper Broadway project area for archaeological resources which almost caused the destruction of a major Native American site last week

2) The County has an obligation to hear public comment before making this decision. As the current owner of these significant historic assets, the County has a critical role in ensuring their stewardship.

The Board of Supervisors and its constituents should be fully informed about these resources before any decisions are made.

Please review the attached Primary Record forms for 515 & 525 Main Street were developed by a historian / consultant who completed an initial survey of the Placerville Historic District for the Friends of Historic Hangtown. Also attached is a map of the Placerville Historic District proposed in 2012 by a Historical Advisory Committee which the City has inactivated.

3) If and when, after being fully informed about its decision, the County proceeds with transferring these historic assets to the City of Placerville, it should only be with conditions that ensure historic preservation.

Please respect the local preservation advocacy and the public at large by a) removing action on 515 & 525 Main Street from the consent calendar (#2), and b) opposing action on any real estate negotiation or transfer of property until you c) hear public comment on this subject.



I appreciate Shiva having added the option back on May 8, 2018 to "explore all other options for the property" in order for a steering committee of organizations to have the opportunity to meet with Don Ashton and Laura Schwartz to discuss a plan for the Old Post Office and Utility Buildings.

I ask that item #2 be pulled from the Consent Calendar in order to have a discussion of the item prior to heading straight into closed session to negotiate with the City of Placerville.

It is not clear how this process works and where it actually is in the process. Our Steering Committee last meet with the CAO's office on July 9, 2019. In order for our organizations to have an audience with the Board did we need to also request a discussion to be held in closed session? When was this decided to actually send out offers for sale of the buildings? When does CEQA come into play? Prior to relinquishing stewardship of these buildings to the City, shouldn't the public be involved as to what the future use will be? Will the County require conditions be placed on the buildings in order to protect the historical elements still remaining inside the buildings?

We have been told that these items being voted on is not a final step in the process for the City of Placerville to acquire the buildings. If not then what is the next step? If so we ask that you pause to hear the presentation from the Steering Committee. There has been much time, money and energy put into the work we presented to the CAO Office by numerous people. Please give us a chance to make our plead.
