FIRST AMENDMENT TO MASTER SUBSCRIPTION AGREEMENT #6830

THIS FIRST AMENDMENT to that Master Subscription Agreement #6830 made and entered into by and between the Client of El Dorado, a political subdivision of the State of California (hereinafter referred to as "Client"), and Granicus, LLC, a limited liability company duly qualified to conduct business in the State of California, whose principal place of business is 408 Saint Peter Street, Suite 600, Saint Paul, Minnesota 55102, (hereinafter referred to as "Granicus").

RECITALS

WHEREAS, Granicus has been engaged by Client to provide a Government Experience Cloud Website Redesign for the Information Technologies Department pursuant to Agreement for Services #6830, dated September 22, 2022, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$63,837.48, and to include a new order form for year four (4) of the Agreement, amending **Section 4.1. Fees.,** and adding **Exhibit A, Order Form**;

WHEREAS, the parties hereto desire to amend the Agreement to update the agreement term, amending **Section 7.1. Agreement Term.**;

WHEREAS, the parties hereto desire to update County's Contract Administrator, amending **Section 10.13. Contract Administrator.**;

WHEREAS, the parties hereto desire to add a new Article to include updated contract provisions, adding Exhibit B, California Levine Act Statement.;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, Client and Granicus mutually agree to amend the terms of the Agreement in this First Amendment to Master Subscription Agreement #6830 on the following terms and conditions:

- **I. Section 4.1. Fees.,** of the Master Subscription Agreement is amended in its entirety to read as follows:
 - **Section 4.1. Fees.** Client agrees to pay all fees, costs, and other amounts as specified in each Order or SOW. Annual fees are due upfront according to the billing frequency specified in each Order or SOW. Granicus reserves the right to suspend and Granicus Products and Services should there be a lapse in payment. A lapse in the term of each Order or SOW will require the payment of a setup fee to reinstate the subscription. All fees are exclusive of applicable state, local, and

federal taxes, which, if any will be included in the invoice. It is Client's responsibility to provide applicable exemption certificate(s).

For the purposes hereof, for the period beginning with the effective date of this Agreement and continuing until the day before the effective date of this First Amendment to the Agreement, the billing rates shall be in accordance with Statement of Work, marked "Pricing Summary," incorporated herein and made by reference a part hereof.

For the period beginning with the effective date of this Amendment and continuing through the remaining term of the Agreement, the billing rates shall be in accordance with Exhibit A, marked "Order Form," incorporated herein and made by reference a part hereof.

Any price increases not negotiated in advance shall be provided by Granicus to Client at least thirty (30) days prior to the end of the Order Term of each Order. Upon each yearly anniversary during the term of this Agreement (including the Initial Term, all Extended Terms, and all Order Terms), the Granicus Product and Services fees shall automatically increase from the previous term's fees by no more than seven percent (7%) per year.

II. Section 7.1. Agreement Term., of the Master Subscription Agreement is amended in its entirety to read as follows:

Section 7.1. Agreement Term. The Agreement Term shall begin on the date of the initial Order or SOW and continue through the latest date of the Order Term of each Order or SOW under this Agreement, unless otherwise terminated as provided in this Section 7. Each Order or SOW will specify an Order Term for the Granicus Products and Services provided under the respective Order or SOW. Each Order or SOW may be added as an Addendum. Client's rights to access or use the Granicus Products and Services will cease at the end of the Order Term identified within each Order or SOW, unless either extended or earlier terminated as provided in this Section 7.

III. Section 10.13. Contract Administrator., of the Master Subscription Agreement is amended in its entirety to read as follows:

Section 10.13. Contract Administrator. The Client's employee responsible for the administration of this Agreement is Amanda Earnshaw, Interim Director, Information Technologies, or successor.

IV. The following section is added in its entirety:

Section 10.14. Levine Act Statement. Pursuant to Government Code section 84308 (SB 1439, the Levine Act), Granicus shall complete and sign the attached Exhibit B, marked "California Levine Act Statement," incorporated herein and made

by reference a part hereof, regarding campaign contributions by Granicus, if any, to any officer of Client.

Except as herein amended, all other parts and sections of Master Subscription Agreement #6830 shall remain unchanged and in full force and effect.
