My name is Joseph Childers, and I am a resident of Placerville. I am writing in support of the Town and Country Village Project proposal for several reasons.


First, the project would provide a much needed community anchor for controlled and targeted commercial development in the Bass Lake area. Currently, that neighborhood exists almost entirely as a bedroom community with no main services outside the Hwy 50 corridor. Because of this, increased development in that area contributes to more traffic as denizens of that community must travel either west toward Sacramento and Folsom or east toward Cameron Park/Placerville. The Town and Country Village project could provide the opportunity for planned, aesthetically pleasing development of services and the potential mitigation of traffic.

Second, the project would provide an important venue for community activities in the area, and contribute to greater community affiliation. Increased development in the area is a foregone conclusion, but the careful planning of the Town and Country Village provides a means to maintain the historical significance and the natural beauty of the surrounding area while accommodating and controlling inevitable growth.

Third, the project would act as a marker of the western edge of El Dorado county. El Dorado Hills has expanded so much that it threatens to completely elide with southeastern Folsom; consequently, the natural gateway into the heart of El Dorado County is more than a little obscured. The Town and Country Village project would function as a significant, and planned, welcome to those traveling west along Hwy 50 into the towns and countryside that make El Dorado County unique, and frankly, attractive to visitors.

To my mind, this project is an example of precisely how a community should address change and positive population growth. I give it my wholehearted recommendation and support.


Growth is inevitable and I trust Mohanna Development Co. to do an incredible job with this project and that will make our county proud.

Please let me introduce myself. My name is Steve Green. I purchased a home and moved to El Dorado Hills at the end of 1989 and have lived here since. I love it here! So much so that I have also purchased a ten acre parcel off Old Bass Lake Road where I intend to build my next home. That parcel is very near the project site referenced above.

I have been aware of this project for quite some time and have attended several community outreach events and two public planning meetings at the fire station off EI Dorado Hills Blvd. As resident of nearly 35 years, I have seen a lot of changes and development around here. But this one is different. It is better. The level of public outreach by the developer has been above and beyond what would be normal, and I believe it has also been fully transparent. If you want information, it is publicly available, plus, the Mohana team has been very responsive to any questions or concerns I have had.
