



RESOLUTION NO.
OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**TAHOE TRUCKEE DISPOSAL CO., INC., dba
TAHOE TRUCKEE SIERRA DISPOSAL**

WHEREAS, a public hearing was held on June 27, 2023 for the purpose of adjusting solid waste collection rates in the Tahoe Truckee Disposal Co., Inc., dba Tahoe Truckee Sierra Disposal, Tahoe-Emerald Bay Franchise Area; and

WHEREAS, County Ordinance section 8.42.150 provides that the Board of Supervisors shall set the rates to be charged by a franchisee at such time as the Board deems appropriate; and

WHEREAS, pursuant to County Ordinance section 8.42.170, the franchisee has provided written notice to each ratepayer of the proposed adjustment in a form approved by the County of the time, date, and place of the public hearing to set rates and the notice was provided at least ten but no more than sixty days before the public hearing; and

WHEREAS, pursuant to County Ordinance section 8.42.170, notice of the time, place, and purpose of the public hearing has been published in a newspaper of general circulation printed and published in the County, once each week, for two consecutive weeks prior to such hearing;

NOW, THEREFORE, be it resolved that for the 2023 Interim year, effective July 1, 2023, the following rates are adjusted upward by five and nineteen hundredths percent (5.19%) for the collection of solid waste within the Tahoe Truckee Sierra Disposal franchise area:
