INFORMATION TECHNOLOGY DEPARTMENT SPECIALIST

DEFINITION

Under general supervision, installs and maintains computer systems, servers, and software for the department to which assigned; ~~identifies appropriate software and systems to meet designs or~~ modifies computer programs for various department ~~needs~~ projects; provides training to end users on the use of hardware and software; works with the Information Services Technology Department and vendors to resolve complex system issues and enhance department systems or resolve problems; and performs related duties as assigned.

DISTINGUISHING SUPERVISION RECEIVED AND EXERCISED

Receives general supervision from assigned supervisory or management personnel. Exercises no direct supervision over staff.

CLASS CHARACTERISTICS

This ~~is an experienced class, a fully competent~~ qualified journey-level classification which provides technical support to department information technology systems and services. Positions at this level perform a wide ~~the full~~ range of training and support activities for users ~~duties as assigned, work independently, and exercise judgment and initiative. Positions at this level receive only occasional instruction or assistance as new or unusual situations arise and are fully aware of a department's computer systems.~~ the operating procedures and policies of the work unit.

This class is distinguished from ~~the~~ Information Technology Department Coordinator in that the latter ~~is responsible for coordinating and participating in the enhancement, maintenance and usage of a critical countywide system.~~ has responsibility for overall direction and coordination of technology systems within the assigned department.

EXAMPLES OF DUTIES/TYPICAL JOB FUNCTIONS (Illustrative Only)

~~Installs~~ Management reserves the right to add, modify, change, or rescind the work assignments of different positions and to make reasonable accommodations so that qualified employees can perform the essential functions of the job.

- Performs a variety of technical support duties within an assigned department; installs and configures personal computer hardware, and system and applications software; serves as first responder to user problems and issues; diagnoses and resolves issues; refers more complex technical issues to central information technology staff or third-party vendors and works with them to resolve these problems.

- ➤ ~~Adds~~ Sets up personal computer hardware, and installs system software and applications software, such as word processing, database, spreadsheet, and graphics programs; adds and removes terminals, user profiles, and security provisions.
- ~~Creates personal computer database applications for department users; identifies needs, develops program, and instructs department staff on use; monitors databases to ensure proper updating and for any other operational issues.~~
- ~~Designs or modifies computer programs for various department projects; gathers information from department staff on specific tasks which require automation; develops scripts; programs code; develops databases; tests with end user for functionality, and monitors performance; prepares technical documentation.~~
- ➤ Provides operational instruction and training to users of the department's personal computer systems; ~~explains operating system commands and the use of department specific applications.~~
- ➤ Reviews and recommends hardware and software options for department use; identifies appropriate generic or specialized software to meet the needs of the department.—
- ~~Sets up personal computer hardware and installs system software and applications software, such as word processing, database, spreadsheet and graphics programs.~~
- ~~Provides technical assistance for users experiencing software or hardware problems; troubleshoots operating problems with printers and other peripheral equipment.~~
- ~~Works with Information Services and/or the system vendor to resolve complex problems.~~
- ~~Instructs department staff in the use of communication networks.~~
- ~~Creates personal computer database applications for department users; identifies needs, develops program and instructs department staff on use.~~
- ~~Instructs users in local area network administration and security; maintains security system requirements.~~
- ➤ Develops training materials, including tutorials, documentation, and ~~instructional~~ instructional manuals for system use.—
- ➤ ~~Performs~~ Performs periodic systems support functions, such as backing up files and loading software updates.
- ➤ Develops and produces standard/ad-hoc reports from department systems.
- ~~May be assigned other department functions, which are within a classification previously held by the employee.~~
- ~~Attendance and punctuality that is observant of scheduled hours on a regular basis.~~

A typical way to graduation from a four year college or university with major coursework in computer science, information systems or a closely related field. OR 2) obtain the required qualifications would be:

Equivalent to ~~completion of a certificate program in computer science or equivalent to possession of an Associate of Arts~~ associate degree with major coursework in data processing or information technology, computer science, or a related field, and two (2) years of experience operating, installing and maintaining personal providing technical support to desktop computer hardware and software systems.

Licenses and/ Certifications:

- Possession of, or ability to obtain, a valid California Driver's License by time of appointment and a satisfactory driving record.

PHYSICAL DEMANDS

Must possess ~~providing training on personal~~ mobility to work in an office setting; use standard office equipment, including a computer; some positions may be required to operate a motor vehicle; vision to read printed materials and a computer screen; and hearing and speech to communicate in person and over the telephone. Standing in and walking between work areas is frequently required. Finger dexterity is needed to access, enter, and retrieve data using a computer ~~software~~. ~~Additional experience may be substituted~~ keyboard or calculator and to operate standard office equipment. Positions in this classification frequently bend, stoop, kneel, and reach to perform assigned duties, as well as push and pull drawers open and closed to retrieve and file information. Employees must possess the ability to lift, carry, push, and pull materials and objects up to 50 pounds, with the use of proper equipment. Reasonable accommodations will be made for ~~the education~~ individuals on a ~~year for year~~ case-by-case basis.

ENVIRONMENTAL CONDITIONS

Employees work in an office environment with moderate noise levels, controlled temperature conditions, and no direct exposure to hazardous physical substances.
