**Recommendations:** It is recommended that your Board approve the results of the official canvass conducted by the Recorder-Clerk-Registrar of Voters.


**Reasons for Recommendation:** Elections Code section 15400 states that the governing board shall declare the results of each election held under its jurisdiction.


