I am writing to ask for a continuance of this item (APPLICATION FOR TRANSFER AND APPROVAL OF RIVER USE PERMIT #20; Item # 2 on July 24 Agenda) until your next Planning Commission meeting.


The current owner of River Otter Adventures owes The Nugget Campground a total of at least \$3603 for unpaid user fees from 2010 through 2013. This is an outstanding debt which is not disputed but which has not yet been paid. In addition, we have received no reports of use or payment for 2014.

River Otter is a relatively small outfitter, and I believed that he had sold his entire operation in late 2010, but he only transferred part of it. As a result I was not aware of his continued use of the Nugget, and this was brought to my attention just recently. When I contacted Mr. Brockman he said his failure to report use to the Nugget, and pay, was because of a change of accountants in 2011. He agreed to pay if I would prepare a bill based on the use reports he submitted to the County. I have done so (bill is attached), and we have not been paid as of today. While I hate to ask for this extension, I have a long planned trip starting today that takes me out of state on the day of the Planning Commission meeting. I had hoped that this would have been resolved by now but it hasn't.
