WHEREAS, the El Dorado County Director of Emergency Services did proclaim the existence of a local emergency on December 31, 2005 at 7:45 a.m. due to conditions of extreme peril to the safety of persons and property caused by a severe storm; and

WHEREAS, on January 5, 2006, the El Dorado County Board of Supervisors ratified the declaration and determined that the declaration be continued until the damages that occurred can be repaired; and

WHEREAS, the El Dorado County Board of Supervisors did find at its regularly scheduled meetings on January 24, February 7, 14, 28, March 14, and 28, April 4, 18, and 25, May 9, 16 and 23, June 6, 13, 20, 27, July 11 and 18, August 15, 22, and 29, September 12, 19, and 26, October 3, 17, 24, 31, November 7, 14, 21, and December 5, 2006 that the aforesaid conditions of extreme peril did warrant and necessitate the proclamation of the existence of a local emergency; and

WHEREAS, said conditions no longer continue to exist

NOW, THEREFORE, BE IT RESOLVED that said local emergency shall be terminated.
