AGREEMENT FOR SERVICES #154-S0711 AMENDMENT I

This Amendment I to that Agreement for Services #154-S0711, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and R.E.Y. Engineers, a California Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 905 Sutter Street, Suite 200, Folsom, CA 95630; (hereinafter referred to as "Consultant");

WITNESSETH

WHEREAS, Consultant has been engaged by County to provide plan review services on an "as requested" basis as necessary for project development for the Developmental Services Department, in accordance with Agreement for Services #154-S0711, dated May 16, 2006, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of said Agreement for one (1) additional year and update compensation, hereby amending **ARTICLE II – Term** and **ARTILCE III – Compensation for Services**; and

WHEREAS, the parties hereto have mutually agreed to amend **ARTICLE X – Notice to Parties** and **ARTICLE XVII – Administrator**; and

WHEREAS, the parties hereto have mutually agreed to add **ARTICLE XXIV – County Business License**.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #154-S0711 shall be amended a first time as follows:

ARTICLE II

Term: This Agreement shall become effective upon execution by both parties hereto and shall cover the period of August 22, 2006 through August 21, 2008.

ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Consultant monthly in arrears. Payment shall be made within thirty (30) days following the County's receipt and approval of invoice(s) identifying services rendered. For the purposes hereof, the billing rates shall be in accordance with Revised Exhibit "B", marked "2007 Fee Schedule", incorporated herein

and made by reference a part hereof. Travel and/or mileage expenses, if applicable, shall be made in accordance with Exhibit "C", marked "Board of Supervisors Policy D-1", incorporated herein and made by reference a part hereof.

The total amount of this Agreement shall not exceed \$30,000.00, inclusive of all expenses.

ARTICLE X

Notice to Parties: All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested.

ARTICLE XVII






