Subject: Changes to Dollar Amount on Group Home/Foster Family Agreements

Pursuant to a request from the Chief Administrative Office we are reducing the dollar amount of group home/foster family agreements that have already been approved by your office. These Agreements are in various stages of approval by the vendors but have not yet been approved by the Board of Supervisors. The dollar amounts are being reduced from a not-to-exceed amount of \$250,000 each fiscal year to a not-to-exceed amount of \$100,000 each fiscal year.
