



RESOLUTION NO. 003-2014

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WHEREAS**, salaries for classifications of Undersheriff, Captain, Lieutenant, Sergeant, and Deputy Sheriff are determined by Section 504 of the El Dorado County Charter; and

**WHEREAS**, classifications of Sr. Investigator (Public Defender), Investigator (District Attorney), and Supervising Investigator (District Attorney), are entitled to commensurate increases per Salary and Benefits Resolution Section 704, Resolution #227-99, and the Memorandum of Understanding between the County of El Dorado and the Deputy Sheriffs' Association Article 4, Section B; and

**WHEREAS**, it has been determined that the classifications of Lieutenant, Captain, and Undersheriff are currently paid at or above the average salary of the classification within the comparator agencies and "at least equal to the average of the salaries for the comparable positions in the South Lake Tahoe Police Department, Amador County Sheriff's Department and the California Highway Patrol", in accordance with Section 504 of the El Dorado County Charter; and

**WHEREAS**, the Chief Investigator (D.A.) has an internal salary relationship with the class of Sheriff's Captain per El Dorado County Law Enforcement Managers' Memorandum of Understanding; thus there is no resulting increase for either classification; and

**NOW, THEREFORE, BE IT RESOLVED** that it has been determined that this resolution shall establish the following approximate salary ranges for the following covered classifications, effective the pay period which contains January 1, 2014.
