

Dear Commissioner and members of the Planning Commission Board. We would like to address a few comments that came from two of our neighbors.

Mr. Sam Griffis and Ms. Teresa Griffis:

The Griffis are expressing concern about us doing weddings every weekend and clogging the road. That is simply not the case. We do not have plans to do more than 15 weddings per year and our visitors are not clogging the roads. Their implication that we have weddings every weekend for extended periods is inaccurate.

It is true that when we do have weddings there are always people clapping and cheering, it is customary for people to cheer when a couple gets married, but the bursts of cheering are short. It is also customary for the couple to have someone photograph their wedding. However, the area topography prevents the Griffis from having a view of the venue from their property. We fail to see how any lights, let alone a camera flash could be seen from their home. As to music, we constantly monitor the decibel level and if it gets close to the limit per county regulations, we inform the DJ that they must turn it down. Like their statement that we do weddings every weekend for extended periods, their comments about cheering every weekend night and photographers using flash cameras to the point of nuisance is an exaggeration.

Lastly, their final two comments are <u>completely unfounded</u>. If anyone has visited our farm, they know that maintaining a clean and firesafe forest is our focus. The Indian Rock Tree Farm has been used as an example of how to maintain a fire safe forest. We would NEVER allow fireworks. **Furthermore, we did not have a wedding on 9/27/24**. Whatever noise they heard was attributed to our family inaccurately.

It should be noted, the Griffis have never expressed their concern or displeasure to our family prior to their note to Planning. If they really believed we were setting off fireworks in the middle of fire season, we would have expected them to either report us to the authorities or stop by for a neighborly chat to express their concern.
