3. Exhibit B, the estimated Project Schedule and Budget is amended through the addition of Exhibit B-1, the Revised Estimated Project Schedule and Budget.

4. All other terms and conditions of the original Agreement numbered CTA-06036 shall remain unchanged and in full force and effect.

Christmas Valley Erosion Control Project

This amendment expands the project boundaries of the existing contract for Christmas Valley 1 for the purpose of using remaining site improvement and acquisition funds, CTA 06 035 and CTA 06 036, in an adjoining area. The adjoining area is Christmas Valley ECP Phase 2, as shown in Attachment 1a. The expansion of the boundaries is consistent with and authorized under the original Christmas Valley 1 staff recommendation which states "Any remaining funds in site improvement projects will be used, if necessary, to extend improvements to adjoining areas". The Board authorized the Christmas Valley Project on March 16, 2007, resolution number 07-03-05. The Board also authorized license agreements on CTC parcels and the MND CEQA for Christmas Valley Phase 2 on May 29, 2009, resolution number 09-05-04.

Project Location Expanded to Include Adjoining Area Phase 2

The Christmas Valley Phase 2 ECP is located on the South Shore of Lake Tahoe, in El Dorado County, south of U.S. Highway 50 in Meyers. The borders of the project area occur at the intersection of Portal Drive and State Route 89 to the south; U.S. Highway 50 to the north; the Upper Truckee River, Minal Street, Blitzen Road, and Wasabe Drive to the west; and Pinewood Drive, Shakori Drive, and Santa Claus Drive to the east (Attachment 1a). The Christmas Valley 2 southern border exactly parallels the Christmas Valley 1 northern border. The borders of the two projects adjoin at the intersection of Portal Drive and State Route 89.

Background

During the initial planning phases, Christmas Valley ECP was one large project. The project split into two phases, 1 and 2, for construction and funding purposes. The construction of Christmas Valley Phase 1 is complete. Phase 2 split into three areas (Areas A, B, C) due to its large size and sub-watershed connectivity, with area A scheduled for construction in fall of 2009. Areas B and C are scheduled for construction in the summer of 2010.

A large erosion control funding balance remains in both the site improvement and acquisition grants budgets from Christmas Valley Phase 1 due to a favorable bid environment and an overestimation of the easement' sizes and values. The remaining erosion control funds from Christmas Valley Phase 1 can help fund erosion control construction and acquisitions activities in the adjoining project, Christmas Valley Phase 2, per the broad authorization given in the initial staff recommendation.

Budget and Schedule

The remaining funds, totaling \$135,762.09 in the erosion control portion of site improvement grant CTA 06035 are allowable for utilization in expanding the project improvements into the adjoining area, Christmas Valley Project Phase 2. Also, the remaining funds in the erosion control portion of the acquisition grant, CTA 06036, totaling \$32,627.80, are also available for use to acquire easements needed for the erosion control improvements in the adjoining area, Christmas Valley Phase 2 ECP. Expanding the project area does not affect the detailed budget breakdown, exhibit B. The schedule for Christmas Valley Phase 2, Areas A-C, is on exhibit B-1.

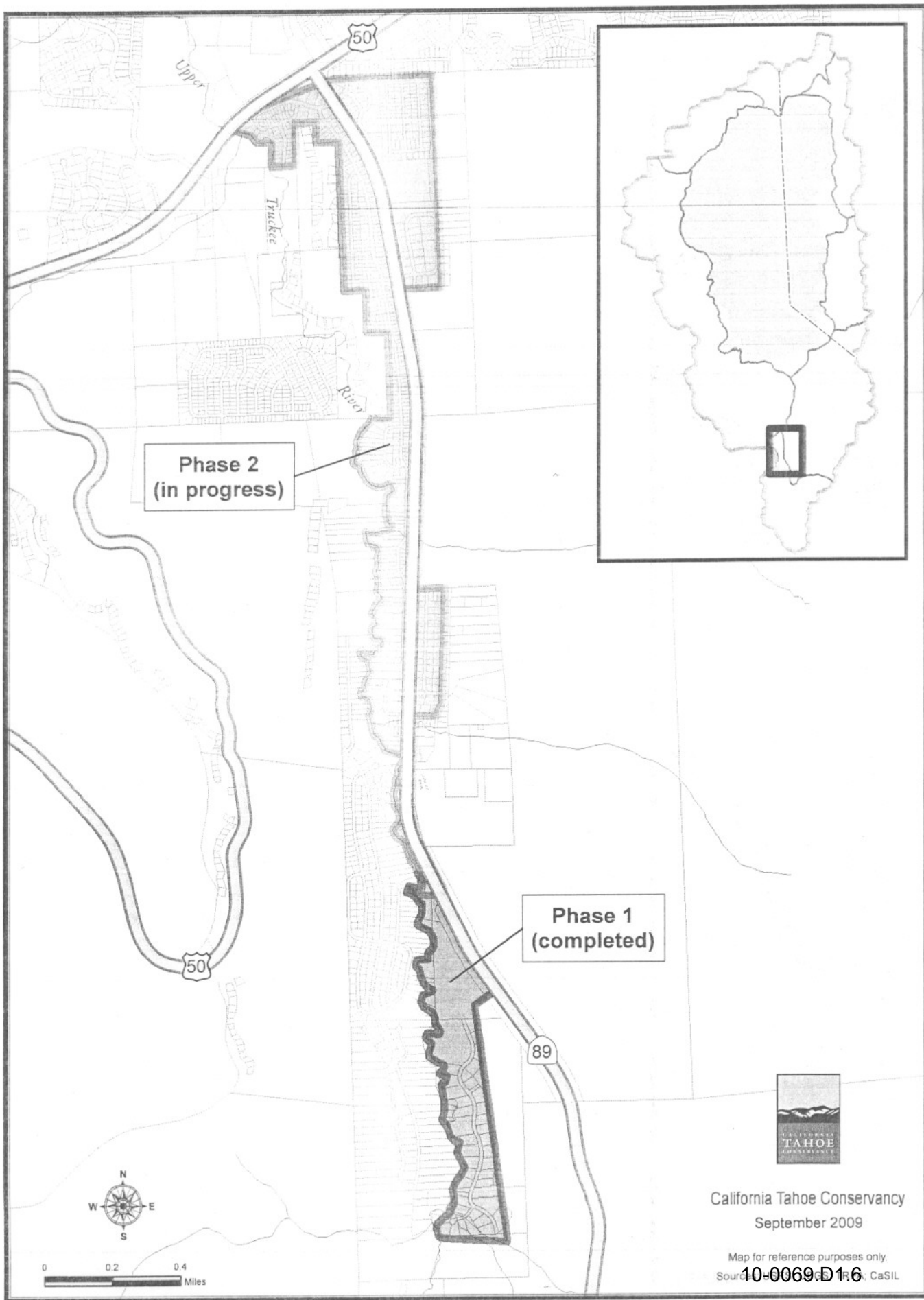
California Environmental Quality Act (CEQA) Compliance

El Dorado County, acting as the Lead Agency, prepared an Initial Study (IS) and a Mitigated Negative Declaration (MND) for this project to comply with CEQA. El Dorado County's Board adopted the MND on February 24, 2009 and a Notice of Determination (NOD) filed on February 24, 2009. The Conservancy Board adopted the CEQA document for the Christmas Valley Phase 2 ECP during the May 29, 2009 Board meeting.

Summary of Authorization for Use of Remaining Funds into Adjoining Areas

- The Board authorization of March 16, 2007 for Christmas Valley 1 allowed for "Any remaining funds in site improvement projects will be used, if necessary, to extend improvements to adjoining areas."
- The Christmas Valley 1 northern border is identical to the Christmas Valley 2 southern border, which is the intersection of Portal Drive and State Route 89, therefore the project areas are adjoining, see attachment 1a for a map of the adjoining project areas.
- This action is consistent with CEQA compliance because the Board already took discretionary actions of adopting the Staff Recommendations, which included certifying the CEQA documents for Christmas Valley 1 and 2. The Board's adoption of the Staff Recommendation for Christmas Valley 1 gives us the authority to use the remaining funds for Christmas Valley Phase 2 site improvement. Therefore we do not need to take this action to the Board and no new CEQA adoption is required. Also new dollars will not change the project as analyzed under CEQA. Therefore no new CEQA analysis is required.
- The Resolution for the initial Staff Recommendation does not need an amendment since the resolution provides for broad authorization of "a total of \$1.21 million for planning, site improvements, and acquisitions of various interests in real property for the Christmas Valley 1, Christmas Valley 2, and Rubicon 5 ECPs."
