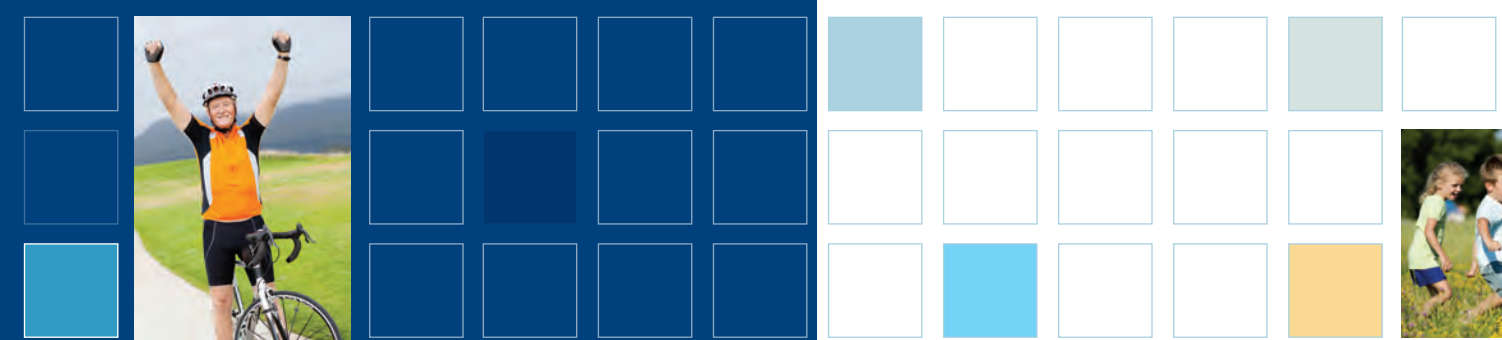

Featured SPEAKER

Tuesday Kick-off Session

Herschel Walker

Former NFL Running Back & Mental Health Awareness Advocate



Herschel Walker is known for his feats on the gridiron: three-time consensus All American, Heisman Trophy recipient, United States Football League MVP, and longtime NFL running back for the Minnesota Vikings, Dallas Cowboys and Philadelphia Eagles. Herschel retired in 1997, having gained more yards than any player in professional football history, counting his seasons in the NFL and USFL.

But while his on-field successes are well documented, what few knew is that Herschel lived with dissociative identity disorder. In 2008, he released his memoir, titled *Breaking Free*. In *Breaking Free*, he shares the inspiring story of his life and diagnosis with this disorder -- from the joys and hardships of childhood, to his explosive impact on college football, to his remarkable professional career.

A mental health awareness advocate, Herschel shows how this disorder played an integral role in his accomplishments and how he has learned to live with it today. His compelling account testifies to the strength of the human spirit and its ability to overcome any challenge.

Walker supports numerous charitable and educational organizations. In 1981, he became the first Academy of Achievement honor student to return to the annual program as a recipient of the Golden Plate Award. In 2002, he was voted into the Collegiate Football Hall of Fame, and was selected as the second greatest player in college football history, just behind the legendary Red Grange.

Innovation SUMMIT

Tuesday Morning

Once again, this year's CSAC Innovation Summit is designed specifically to help county officials learn creative solutions other local governments are using to lower the cost of doing business, grow and sustain economic development and enhance citizen quality of life. This is a must-attend event for county elected and appointed officials looking for practical solutions to maintain or enhance services during this time of tremendous change.

Come hear from your peers – County Supervisors, Administrative Officers and others – about the solutions they are using to do more with less. This half-day session will showcase some of the most creative county leaders in the state sharing their innovative solutions for surviving and thriving during times of tremendous change.

The Innovation Summit will include panels on topics such as improving employee health while containing costs and reducing jail liability.



Featured WORKSHOPS

Tuesday Afternoon

A CSAC Dialogue on Water

This workshop is for county officials who are interested in discussing California's water quality and supply issues. Led by a neutral facilitator, county supervisors and other from around the state will have an opportunity to discuss the biggest water challenges facing their region. The goal of the meeting is to provide a venue where county officials can have a candid conversation about California's water issues, build trusting relationships and discuss real solutions that supervisors can take back to their districts.

Leveraging Funding and Tools to Create Safe and Healthy Communities for Walking and Bicycling

This workshop will examine successful county efforts to create safe and healthy neighborhoods for walking and bicycling. Communities that collaborate to encourage "active transportation produce multiple benefits for their residents. The session will include an interactive discussion with county officials who have been leaders in active transportation and will introduce participants to a newly released online toolkit designed to inform local decision-makers about funding, technical and policy options available.

Wednesday Morning

2011 Realignment: Exploring Innovative County Approaches

This session will explore elements of several counties' approaches to managing the criminal justice responsibilities transferred to counties under 2011 public safety realignment. Drawing from just over two years of programmatic experience, counties will discuss population-specific approaches, successful strategies to ensure offenders are plugged into the appropriate type and level of services, and efforts to evaluate whether practices and interventions are producing desired outcomes.

Healthy Counties: Improving Wellness and the Bottom Line

Counties are discovering the benefits of leveraging resources to create healthy communities. Wellness efforts may not only shrink waistlines, but also the bottom line. From ambitious, countywide 10-year health goals to programs targeting high-risk populations, participants will explore the myriad ways in which community wellness programs can address expensive health-related conditions and boost productivity –even increase happiness. Healthy counties mean a healthy future.

Wednesday Afternoon

The Affordable Care Act: Preparing for Change on the Eve of Health Care Reform

The Affordable Care Act (ACA) may be a federal statute, but California's counties must contend with multiple direct impacts due to our roles as health care providers, eligibility and enrollment hubs, and employers. Join county experts in an interactive conversation to learn about the key components of the Act and how counties across the state are preparing for the changes ahead.

Travel and Tourism: An Important Part of a Healthy Economy

The travel and tourism industry is vital to California counties' economic health, providing nearly a million jobs for Californians and injecting \$6.6 billion in tax revenue into local and state government. In this session "Visit California" President & CEO Caroline Beteta will share how the organization markets the Golden State around the world and discuss how your county can work with Visit California to grow business for local hotels, restaurants and destinations.

Thursday Morning

Homelessness in California: What's Working?

The topic of homelessness has recently come to the forefront in state and national politics. While the state and federal government can guide and produce policy related to the problem, counties carry it out firsthand by providing transitional and permanent housing, partnering with non-profits and faith-based organizations, creatively using state and federal funding and developing cross-system policies that interconnect the issue of homelessness with policies dedicated to mental health and public safety. Come learn and participate in a discussion about how several counties have developed effective strategies to reduce homelessness, as well as what can be done at the state and federal levels to aid counties in their efforts.

Social Media: Balancing Risk, Transparency and Innovation

The use of social media outlets has exploded in recent years, allowing users to develop relationships, share information and network. For local government, this platform can provide a voice and forum to citizens and allow for public agencies to share important information about the community. But how can counties ensure that this type of communication doesn't open them up to policy and legal issues? This workshop will highlight the importance of understanding how social media works, the legal questions associated with using it as a public agency (with regard to freedom of speech and public meeting and records laws) and how to create and maintain a social media policy in your county.

CSAC Wednesday General Session

Maria Hinojosa

Emmy Award-Winning Journalist



For 25 years, Maria Hinojosa has helped tell America's untold stories and brought to light unsung heroes in America and abroad. In April 2010, Hinojosa launched The Futuro Media Group with the mission to produce multi-platform, community-based journalism that respects and celebrates the cultural richness of the

American experience. She is currently reporting for Frontline on immigration detention.

As the anchor and managing editor of her own long-running weekly NPR show, "Latino USA," and anchor of the Emmy Award-winning talk show Maria Hinojosa: One-on-One on WGBH/La Plaza, Hinojosa has informed millions of Americans about the fastest growing group in our country. Previously a senior correspondent for NOW on PBS and currently a contributing correspondent for Need to Know, Hinojosa has reported on hundreds of important stories - from the immigrant work camps in NOLA after Katrina to teen girl victims of sexual harassment on the job to Emmy Award-winning stories of the poor in Alabama.

Hinojosa has won top honors in American journalism including two Emmys and the John Chancellor Award for Excellence in Journalism from Columbia University's Graduate School of Journalism.

Throughout her career, she has helped define the conversation about our times and our society with one of the most authentic voices in broadcast. Her investigative journalism and presentations press for truth while giving voice to lives and stories that illuminate the world we live in.

CSAC Institute COURSES

(Require Separate Registration)

The CSAC Institute for Excellence in County Government was established in 2008 to provide professional continuing education opportunities for California County Supervisors, other elected officials and senior staff. The Institute offers an array of comprehensive courses on leadership, governance and county policy.

Monday Morning/Afternoon

Leadership and Change: Practices to Move Organizations

Elected officials and executives alike discuss the need for change in their organizations, yet struggle when change seems difficult to accomplish within the depths of the organization. This course helps participants move past technical solutions to the leadership necessary for approaching adoptive challenges. Discussion highlights why some changes happen relatively quickly while others are stymied. Participants explore change from the perspective of those who the change affects. A simulation allows participants to examine the change process. Practical discussions focus on design of a change process, practices to diagnose, interpret and select interventions, and creating an environment in which participants and their employees expand their capacity to address adaptive change.

Tuesday Morning

Interpersonal Relations – Why Won't They Change for Me?!

The key to interpersonal effectiveness – and improving your interaction with others – is better understanding yourself. Effective elected officials and senior executives have discovered the more they understand their reactions to others, know how to capitalize on their personal strengths, are able to exude an air of confidence, and have the ability to adapt their behavior to meet the needs of others – the more effective they become in achieving results with others. Learn how in this lively and insightful class.

Institute COURSES (continued)

Thursday Afternoon

Public Engagement in the County Budget Process

County Boards and executives must make difficult decisions in the budgeting process which affect county services and quality of life for the community. This course explores methods for community involvement in the budget process to help counties generate new ideas, make effective decisions and build public acceptance of decisions. Participants explore practical tips to maximize the effectiveness of public forums, budget hearings, town halls, and other forms of community engagement in budget decisions. Participants examine techniques that help the public take into account the hard choices and trade-offs in decisions, and how to demonstrate that public ideas and recommendations are taken seriously.

Friday Morning

The Affordable Care Act, Realignment and California Counties

Together, the intersection of the Affordable Care Act (ACA) and Realignment account as the most significant change to county services and funding since Proposition 13. The state/county fiscal relationship has shifted once again on the eve of the ACA implementation. Join county experts to learn more about the key fiscal and operational components of AB 85 and the potential impacts for all counties after January 1. Also examine the future of indigent care delivery, local public health programs and other elements of county implementation of ACA. It is anticipated that many of the implementation decisions will be made by this time, and this course will pull those together in a comprehensive manner for policy makers.

Dr. David Berson

Economist



Dr. David W. Berson leads a team of economic analysts at Nationwide Insurance to deliver economic forecasts and analyses that are used to inform and strengthen business strategies and operating plans.

David is a noted economic expert, who holds a doctorate in economics and a master's degree in public policy from the University of Michigan, and a bachelor's degree in history and economics from Williams College.

Prior to joining Nationwide, David served as the Chief Economist & Strategist and Head of Risk Analytics for The PMI Group, Inc., where he was responsible for analyses and forecasts of the economy, housing, and mortgage markets; domestic/global research and planning; and strategic planning. He also acted as a PMI spokesperson on global economic topics related to housing and mortgage market conditions and policies.

David has also served as Vice President and Chief Economist for Fannie Mae, where he advised the company on national and regional economic, housing and mortgage policy and conditions, including forecasts and analyses of the economy, interest rates, and housing and mortgage finance markets.

David has also been Chief Financial Economist at Wharton Econometrics, visiting scholar at the Federal Reserve Bank of Kansas City, assistant professor of economics at Claremont McKenna College and Claremont Graduate School. His government experience has included staff economist on the Council of Economic Advisors and economic analyst at the Treasury Department and the Office of Special Trade Representative. He is a past President of the National Association for Business Economics (NABE).
