RE: Silva Valley Parkway Interchange Project (#71328), El Dorado Hills

Dear Mr. Smeltzer :

I will be coordinating the relocation of PG&E's facilities to accommodate your proposed project at the location described above. Currently, we have determined there are electric transmission facilities that need to be relocated.

The approximate cost for PG&E to do the entire project is \$1,000,000. These figures are **very preliminary** and have been derived without benefit of preparing a formal estimate and are provided to give you a very rough cost estimate for your planning purposes.

In order to give you a more accurate cost to relocate PG&E's electric facilities finish design, engineering, and land work including required application to the California Public Utilities Commission (CPUC) to satisfy General Order No. 131-D requirements, you will need to provide PG&E with an additional \$40,000 over and above the advance deposit of \$30,000 we have already received. You may request at any time that we stop preliminary work on this project. Any actual costs incurred up to that time will be deducted from your advance deposit and the balance, if any, refunded without interest. I have attached some general information regarding the G.O. 131-D requirements for your files

The work performed for this project will be pursuant to Section 13.12.02.01 (Oversight of Locally Funded State Highway Projects) of the Caltrans Right of Way Manual. As specified in this section the Caltrans Utility Coordinator provides oversight on locally funded State Highway projects. Oversight includes the activity of monitoring as well as the effort of assisting, guiding, and advising the Local Public Agency (LPA) to ensure that all utility adjustments and encroachments are accomplished in accordance with the Department's policies, procedures, standards, practices, statutes, contracts, and agreements. Within this context, use of State mandated forms shall be required of all LPAs and/or their consultants. Where protection, relocation, or removal of facilities is required, the work shall be performed and liability determined in accordance with:

State law, policy, procedure, contracts, and agreements for those facilities located within the project limits providing improvements to the State highway.

Local agency policy and procedures for those facilities located outside the project limits of the State highway.

This requires the local agency to adhere to all requirements of the State's Master Contracts for work related to the State project limits of the locally funded project. PG&E has an existing Master Contract with Caltrans to which the requirements would adhere.

Once we have developed more accurate costs, you will be required to enter into a utility agreement with PG&E for the County's share of the cost.

Please have this letter signed and returned with your deposit in the amount of \$40,000. The enclosed envelope has been provided for your convenience. We can not continue with the project until we receive the deposit.

I hereby request PG&E to continue the engineering work for the relocation of PG&E's electric transmission & distribution facilities subject to the terms and conditions stated above.


