

To quote our Constitutional Sheriff D'Agostini, "...*Hold their feet to the fire. Mine too. I work for you.*"

Weekly citizens come before the BOS to conduct the people's business. Rarely do they receive a response to legitimate questions that the public has a right to know. Or, as was the case on August 27th, Chairman Briggs called a recess and walked out of the room without cause when challenged about his lack of transparency & accountability to constituents.

During Open Forum last week I delivered a very serious message when I reminded the Board that silence is consent. **Consent** means to acquiesce, agree, permit or allow. Supervisor Mikulaco's mocking and exaggerated Cheshire cat grin was very disturbing and disrespectful. The week before Counsel was caught on video winking at reporter Chris Daley regarding LUPPU issues.

On August 27th I submitted to the Board two California Public Record Act requests for information which the law says you are required to respond within 10 days. Two days delinquent I received a partial response via electronic transmission from the Clerk to the Board combining both CPRAs into a chaotic mess.

Such conduct by public servants raises more questions about the function of El Dorado County leadership than it answers. Was the intention to deliberately *deceive*, was it a matter of staff *incompetence*... or is it just the typical BS—**Bureaucratic Shenanigans?**

WE DO NOT SILENTLY CONSENT TO ABUSIVE CONDUCT BY OUR PUBLIC SERVANTS.

Counsel, you've also taken an oath of office. We are concerned about the demonstrated inconsistencies of our elected representatives. An explanation is in order. Would you please respond for the record?

CA Public Records Act Request

Pursuant to my rights under the California Public Records Act (Government Code Section 6250 et seq.), I ask to obtain a copy of the following:

1. Copies of all **Temporary Special Use Permit** authorizations and relevant financial records submitted to the **Planning Department** during the years **2009 to 2012** inclusive pertaining to the **July 25, 2012 Toe Up Cup** event at Troublemaker Rapids held at the **American River Resort**.
2. A copy of the **formal petition of signatures dated June 4, 2002** addressed to Conrad Montgomery in Planning requesting the revocation of the **American River Resort SUP #S91-06** and the **Coloma Resort SUP #S93-03** for repeated violations of sound/noise ordinances within the Quiet Zone of the American River submitted by Melody Lane on behalf of local residents, and again submitted during a meeting held on **August 9, 2012** with Pierre Rivas and Roger Trout (Planning/Development Services.)

It is requested that your determination is made within **10 days** as stipulated within the California Public Records Act.

If you determine that some but not all of the information is exempt from disclosure and that you intend to withhold it, you are asked to provide a signed notification citing the legal authorities on whom you rely.
