Re: El Dorado Ranch Phase 1B Purchase - 9/16/14 Board of Supervisors Agenda

Members of the Board:

I would like to register my support for the acquisition of the El Dorado Ranch Phase 1B by the American River Conservancy and El Dorado County participation in the purchase with a \$120,000 allocation from the County's Oak Woodland Preservation Account.

American River Conservancy has secured \$4,875,000 of the \$4,995,000 purchase price, leaving \$120,000 to be funded for this 1,080 acre property, fronting the Cosumnes River. The County's oak woodland management plan has identified the property as a "priority conservation area." The property appraised at just under \$6 million and the owner is donating \$945,000 of the property value to the acquisition. Every dollar of the \$120,000 Oak Woodland Preservation Account allocation would, in effect, be matched by about \$50 of other funding for the acquisition.

With the adjoining 1,059 acres already purchased, there is a unique opportunity to create an exceptional public trails system on the upper Cosumnes River. Coupled with a unique opportunity to leverage County oak woodland mitigation funds to acquire more than 1,000 acres of prime oak woodland landscape, I see no better use of these funds. I therefore urge the Board to approve the allocation of oak woodland mitigation fees to the El Dorado Ranch Phase 1B project.
