

RESOLUTION NO. 323-2006

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Resolution of

BE IT FURTHER RESOLVED that that Resolution No. 252-81, which establishes parking restrictions pursuant to Section 10.12.010 of the El Dorado County Ordinance Code, is amended as follows:

ADD:

(ea) "NO STOPPING ANY TIME" along the east side of Brittany Way (No. 2709) beginning at Suffolk Way (No. 1139) and continuing north for a distance of 180 feet, and along the west side of Brittany Way (No. 2709) beginning at Suffolk Way (No. 1139) and continuing north for a distance of 75 feet."

(eb) "NO STOPPING ANY TIME" along the south side of Suffolk Way (No. 1139) beginning at Brittany Way (No. 2709) and continuing west for a distance of 100 feet, and along the north side of Suffolk Way (No. 1139) beginning at Brittany Way (No. 2709) and continuing west for a distance of 75. Thence, along the north side of Suffolk Way (No. 1139) from a point 200 feet west of Brittany Way (No. 2709) and continuing west for a distance of 50 feet, ending at the school driveway."

(ec) "NO STOPPING SCHOOL DAYS 7:00 AM TO 5:00 PM" zone along the west side of Brittany Way (No. 2709) beginning at a point 75 feet north of Suffolk Way (No. 1139) and proceeding north for a distance of 650 feet."

(ed) "NO PARKING" along the north side of Palmer Drive (No. 424) from a point 315 feet east of Gabbert Drive (No. 425) to a point 465 feet east."

(ee) "NO PARKING" along the south side of Palmer Drive (No. 424) from a point 140 feet east of Gabbert Drive (No. 425) to 10 feet west of Gabbert Drive (No. 425) and from a point 450 feet west of Gabbert Drive (No. 425) to a point 600 west of Gabbert Drive (No. 425)
