Dear Members of the Board of Supervisors:

Light of the Hills Lutheran Church (LOTH) has applied to amend our existing use permit to cover our two five acre parcels to build a two-story 13,720 square foot building instead of two separate buildings totaling 18,000 square feet, as indicated on the original use permit, and install a ball field. Additionally, LOTH has requested that one of our parcels currently zoned R2-PD be rezoned to RE5.

At El Dorado County Planning Commission Hearings, on 25 October and 8 November 2007, our amended use permit was approved as submitted to, and recommended by, the Development Services Department Planning Staff with the exception of a restriction to the ball field inserted by the Planning Commission. The restriction prohibits the use of LOTH's ball field by organized sports leagues. LOTH takes exception to this ball field restriction.

One of the primary purposes of LOTH is to serve the community. One example of this is the large number of Community groups that use our existing facility. As we know you are aware, there is a significant shortage of ball fields in El Dorado County for our kids to use. The goal of installing a ball field that can be used for free by our kids in El Dorado County, including organized sports teams, in is line with our existing goals of serving the people in our community.

While there are a large number of supporters for our ball field, there is a small group of people that oppose the use of our planned ball field by people outside of our church, such as organized sports teams, due to a perceived increase in noise and traffic. LOTH disagrees with the idea that additional noise and traffic would be generated by the ball field. Independent traffic and noise studies, and the County Planning Services Staff report indicate that there will be very low, if any, impact from noise and traffic above the current background due to the highway 50 freeway, Safeway Shopping Center complex, Food for Less Shopping Center complex, and Burke's Junction complex across the street.

In addition, if the public use of the ball field cannot be approved, we are asking to withdraw our request to rezone our R2-PD parcel to RE5, so as not to limit our property use options.

We respectfully request that the Board of Supervisors remove the restriction prohibiting organized sports leagues from using our planned ball field so that the entire community can use our entire facility.

I support and favor the installation of a day use ball field at Light of the Hills Lutheran Church in Cameron Park that can be used by organized sports teams.


Please support the children in our El Dorado County Community by voting in favor of the church's planned ball field at your December 11 Board of Supervisors meeting.
