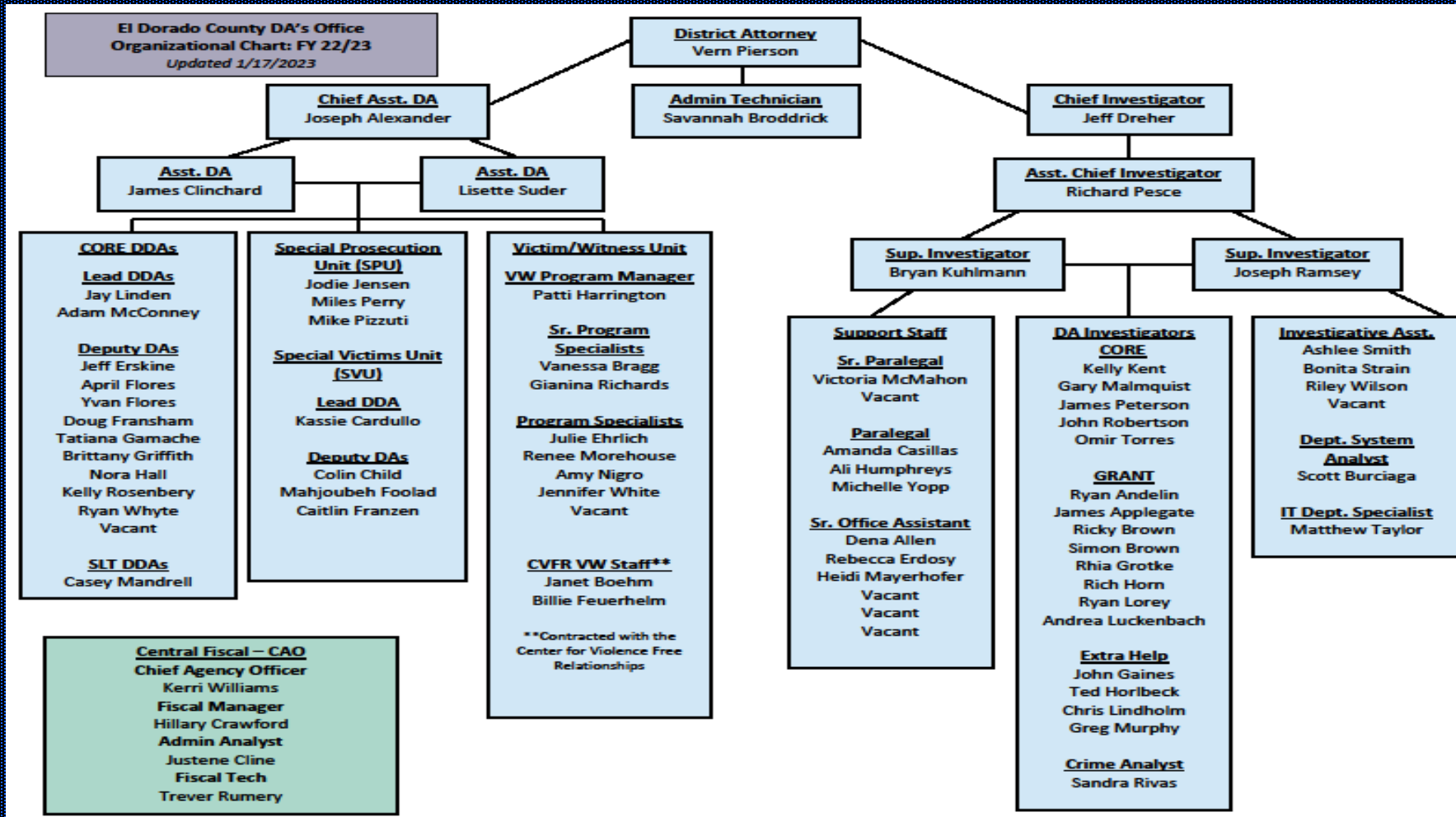

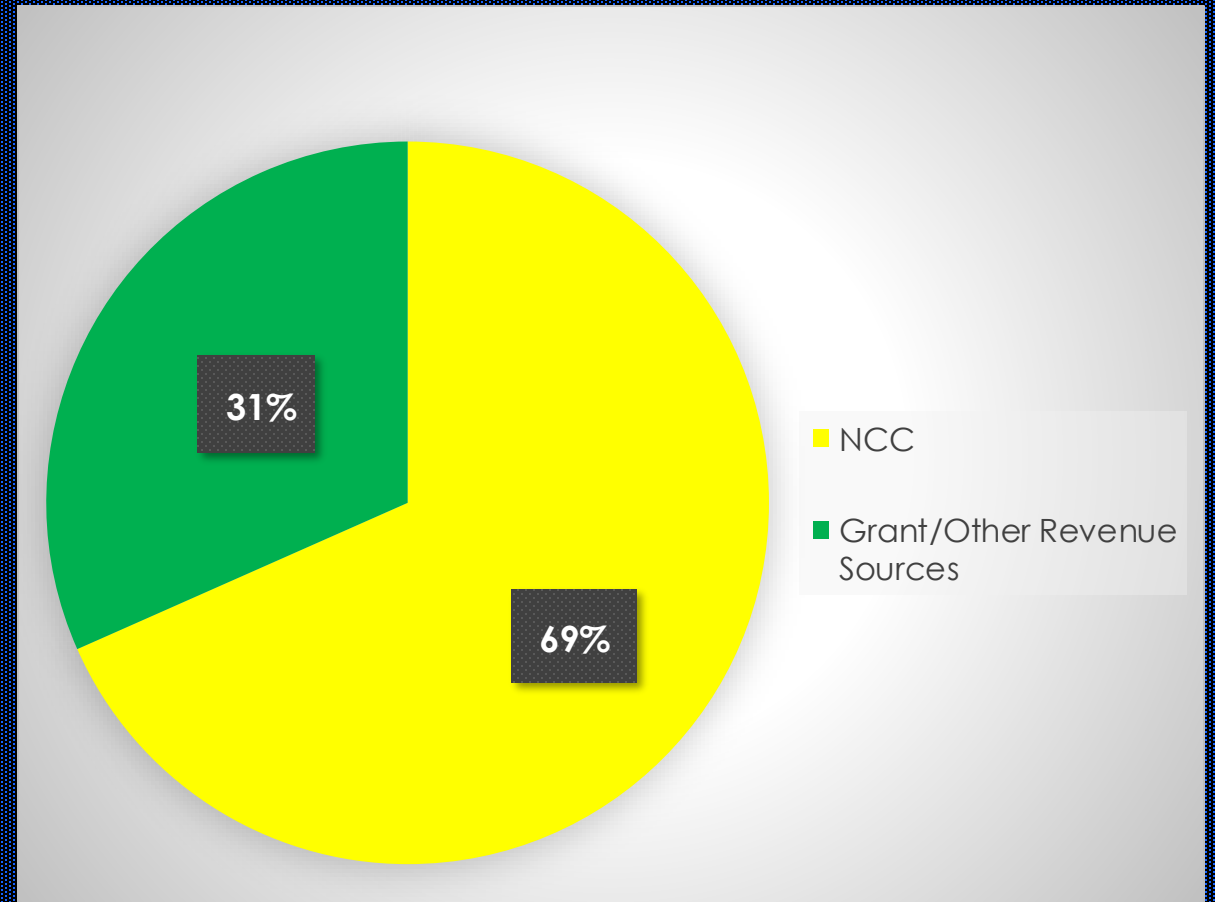

ACCOMPLISHMENTS 2022

- **CHILD ADVOCACY CENTER**
 - COMPLETED THE NATIONAL ACCREDITATION PROCESS (AWAITING FINAL APPROVAL REPORT)
 - OVER 120 MDI CONDUCTED
- **FENTANYL ADVISEMENTS & FENTANYL-RELATED DEATH POLICY**
 - 21 FENTANYL-DEATHS IN EDC IN 2022 (11 CASES STILL PENDING TOXICOLOGY)*
- **IMPLEMENTED ADVISEMENT PROTOCOL SIMILAR TO "WATSON" ADVISEMENTS**
- **CHARGING POLICY TARGETING SUPPLIERS & HOLDING THEM ACCOUNTABLE**
- **SCIENCE BASED INTERVIEW AND INTERROGATION**
 - RECOGNIZING THAT CERTAIN WIDELY USED INTERROGATION TECHNIQUES ARE MORE LIKELY TO PRODUCE FALSE ADMISSIONS AND CONFESSIONS, WE HAVE SPEARHEADED A PROGRAM TO EDUCATE LAW ENFORCEMENT AND PROVIDE TRAINING IN SCIENCE-BASED INTERVIEW TECHNIQUES THAT HAVE BEEN SHOWN TO BE MORE EFFECTIVE AND MORE LIKELY TO PRODUCE RELIABLE STATEMENTS FROM SUSPECTS, WITNESSES AND VICTIMS. IN 2022, WE HAVE TRAINED APPROXIMATELY 100 LEO AND DDA IN SBI. CA POST IS NOW INCORPORATING SBI INTO ITS STANDARD CURRICULUM.
 - IN CONNECTION, OUR OFFICE HAS IMPLEMENTED A FILING POLICY THAT REQUIRES PRE-FILING MANAGEMENT-LEVEL APPROVAL OF ANY CASE WHERE THERE IS A PROBLEMATIC INTERVIEW OR INTERROGATION. THIS POLICY IS DESIGNED TO ELIMINATE THE USE OF CONFESSIONS OBTAINED THROUGH THREATS, DECEPTION, OR PSYCHOLOGICAL MANIPULATIVE INTERROGATION TACTICS. THIS POLICY HAS BEEN ADOPTED BY OTHER DAO AND IS WIDELY VIEWED AS A "BEST PRACTICE."

 - IN OUR CONTINUED GOAL OF MODERNIZING OUR OFFICE WE LAUNCHED INTO A DIGITIZATION CONTRACT TO SCAN OLD PAPER CASE FILES AND IMPORT THEM INTO OUR CMS. WE HAVE SCANNED MORE THAN 300 BANKER BOXES OF FILES THIS FAR.

CURRENT & FUTURE CHALLENGES

SB 1338 - CARES COURT: MANDATORY IMPLEMENTATION OCTOBER, 2024

SB 2778 - RACE-BLIND CHARGING: MANDATORY IMPLEMENTATION JANUARY, 2026

AB 2418 - CRIMES JUSTICE DATA ACCOUNTABILITY AND TRANSPARENCY: MANDATORY IMPLEMENTATION JUNE, 2027

- 54 SPECIFIC CATEGORIES OF DATA THAT MUST BE INPUT...AND 30 SUB-CATEGORIES.
- WILL REQUIRE DEVELOPMENT OF PROGRAMS AND HIRING OF DATA ANALYST AND PROGRAMMER.

EXPECTED INCREASE IN ATTORNEY WORK-LOAD DUE TO:

- IMPLEMENTATION OF ALL THESE NEW LAWS
- CHANGES IN CASE PROCESSING AND BUSINESS MODEL (TRANSFERRING TASKS FROM SUPPORT STAFF TO DDA)
- CONTINUING EXPANSION RELATED MANY OTHER CHANGES IN THE LAW IN THE LAST SEVERAL YEARS
- MENTAL HEALTH DIVERSION CASES INCREASING
- VET COURT CASES INCREASING
- MISDEMEANOR DIVERSION CASES INCREASING
- POST LITIGATION CASES INCREASING
- LENGTH OF CASE FROM BEGINNING TO END HAS EXPONENTIALLY INCREASING DUE TO CHANGES IN LAW RELATED TO BAIL, SENTENCING, COVID, DIVERSION
- INCREASED PAROLE HEARINGS DUE TO EXPANDED PAROLE OPPORTUNITIES
