Supervisor Mikulaco,

I am a constituent in your district. We've lived in the Bass Lake area on Watsonia Glen Drive since 1995. I've seen local reports that the Board will be meeting in closed session on Tuesday May 20th to review matters related to the recent trial of Supervisor Nutting.

While I am by no means a supporter of Supervisor Nutting, I am asking that you, as a representative of District One, vote to end these political games, and have the Board get back to the business of El Dorado County, and ignore the business of political infighting instigated by District Attorney Pierson (whom I have voted for previously, but never will again) and Auditor-Controller Harn. I am ashamed of the conduct of elected members of our county government, who seem to only pursue personal projects, the enrichment of political allies, and empire building.

Supervisor Nutting was convicted of misdemeanors. Traffic violations are misdemeanors. By electing to remove Supervisor Nutting from the Board for misdemeanors, the Board, and other elected officials in this county, are opening themselves up for removal for similar misdemeanor verdicts.
