

Second Amendment to Agreement No. 007E-A-11/12-BOS Between the County of El Dorado and Decade Software Company, LLC

THIS SECOND AMENDMENT TO AGREEMENT NO. 007E-A-11/12-BOS made and entered by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Decade Software Company, a Limited Liability Company, duly qualified to conduct business in the State of California, whose principal place of business is 1195 W. Shaw Ave., Fresno, CA 93711 (hereinafter referred to as "Consultant") hereby amends the Agreement as follows:

WITNESSETH

WHEREAS, County will provide food inspection information online to the public; and

WHEREAS, County has determined that additional software services are required to implement the public access online food inspection module of the Envision Connect software application, the parties hereto have mutually agreed to amend Article 5, Item h, and Exhibit A incorporated herein and made by reference a part hereof; and

WHEREAS, Consultant has represented to County that it is specially trained, experienced, expert and competent to perform the additional services described herein, in conformity with all applicable State laws and requirements related to the Health and Safety Code, and County has determined to rely upon such representations.

NOW, THEREFORE, County and Consultant mutually agree that Agreement No. 007E-A-11/12-BOS be amended a second time as follows:

ARTICLE 5

Compensation for Services:

h. The total payment pursuant to this Agreement shall be amended to increase the total amount by Seven Thousand Two Hundred Forty Five Dollars (\$7,245). The additional funding provides \$2,520 for the Press Agent Setup and Configuration and \$262.50 per month, for eighteen months, for additional Press Agent License and Support Fees. The total payment under this Agreement SHALL NOT EXCEED One Hundred Sixty One Thousand One Hundred Seventy Four Dollars (\$161,174).

All other sections of the Agreement No. 007E-A-11/12-BOS, dated the 15th day of November, 2011, and the First Amendment to Agreement No. 007E-A-11/12-BOS, dated the 25th day of September, 2012 shall remain unchanged and in full force.
