El Dorado County Health and Human Services Agency Child Protective Services Process Improvement SOW Amendment 1

1.0 SOW Introduction

El Dorado County has entered into an agreement with the Change and Innovation Agency (C!A) to provide business process improvement services for their Child Protective Services program.

This amendment describes the additional work to be performed in association with the initial statement of work to expand on the implementation and support activities.

This document describes the scope, approach, staffing and schedule of the tasks necessary to complete this objective.

2.0 Implementation Planning

Following the workshop improvement report, the team will complete analysis and planning activities to detail the specifically approved improvements to determine the scope and approach to implement each. This includes determining impacted staff, expected benefits, associated metrics and risks. These are then grouped and sequenced for implementation.

The resulting analysis is presented as an implementation plan that prepares the County for a change management effort.

Tasks

- 1. Improvement Report Review Meeting with leadership as appropriate to discuss the ideas resulting from the workshop to evaluate implementation ideas, improvement idea scope, and associated impacts.
- 2. Metric Evaluation An analysis of current data associated with the improvement ideas.
- 3. Implementation Planning Development of a plan to implement the analyzed improvements.

Deliverables

3.4 Implementation Action Plan – The deliverable includes the key implementation events and a task list with deliverables, owners, and anticipated completion dates.

3.0 Change Management Planning

The change management plan included in the initial scope of work is refined to focus on specific implementation change management needs for the approved items in the implementation plan. The action plan is created for each change that requires change management and implementation work. A single document is created that contains each approved change with a set of tasks, objectives, approaches and suggested timeline for effective change management, implementation, and support. The plan includes assignments and schedule for implementation.



4.0 Countywide Rollout Support

The countywide rollout support task from the initial statement of work is expanded to six months of direct support to execute the change management plan, and to maintain and sustain the changes included in the change management plan. This includes development of training material, reviewing data and spending time with supervisors and/or staff to reinforce the process improvements that were selected for implementation. On a monthly basis the support plan is adjusted based on current process change status and resulting needs.

Deliverables

5.1 Rollout Support Report – Monthly report that describes the key activities provided during roll-out.

5.0 Roles and Responsibilities

No changes.

6.0 Schedule

The initial schedule remains, with 5 additional months of support provided.

7.0 Cost

The following are the costs of each phase of work. The payment schedule follows the key deliverables in the SOW as shown in the table below.

Each deliverable is approved by the project sponsor and provides an opportunity to evaluate the quality of the work.
