Dear Board of Supervisors,

I am contacting you to express my concerns about this upcoming school year and the current recommendation for children to be masked within school. **Dear Board of Supervisors,**

I am writing this email in support of the Resolution on Healthy Children. I plead with you to stick by that resolution and make masks optional next school year regardless of vaccine status.

Dear Supervisors,

Thank you for putting the Healthy Children Resolution (#069-2021) on your agenda for 6.29.21. I write to declare my support for the resolution and ask that you pass it with flying colors. Our children have suffered immensely because of the Covid restrictions/protocol put in place by the California Department of Public Health. They have been subject to constant masking, which restricts breathing, even during outside play, recess and sports. Masking children has been shown to cause developmental problems, emotional problems, distracts from learning and is physically unhealthy for children. Further, it has been established that children are at low risk and do not transmit Covid 19. Teachers, administrators and students over 12 who want the vaccine have had an opportunity to get it. There is no longer a need for mandatory masking, and it is now causing more harm than good. If masks are required in the fall, I will withdraw my student from John Adams Academy and enroll him in a private school where masks are optional.

Historically, we have entrusted and empowered local school districts to determine safety and health protocol that best suits the needs of their students. Covid 19 response/protocol is no different. Decisions regarding masking, quarantines, testing should be made locally be each school district. The past year has shown that CDPH did NOT act in the best interest of our children, and prioritized politics over children. They even allowed the teachers' union to write the reopening plan! Teachers' unions are NOT policy or health experts and have NO BUSINESS directing public policy for millions of California children.

We elected you to keep our community from harm, and protect our basic, fundamental rights. You are obligated to US, not Gavin Newsom or CDPH! Show your support for US, your constituents by approving and adopting the Healthy Children Resolution on 6.29.21.
