PROTOCOLS FOR PUBLIC COMMENT:

Commission meeting.

Public comment will be received at designated periods as called by the Commission Chair.

Except with the consent of the Commission, individuals shall be allowed to speak to an item only once.

Matters not on the agenda may be addressed by the general public during Public Forum/Public Comment. Comments during Public Forum/Public Comment are limited to three minutes per person. The Commission reserves the right to waive said rules by a majority vote. Public Forum/Public Comment is for comment only. No action will be taken on these items unless they are scheduled on a future agenda.

Public testimony will be received on each agenda item as it is called. Individuals will have three minutes to address the Commission. At the discretion of the Commission, time to speak on an item may be extended or shortened for all speakers.

Upon completion of public comment on an agenda item, the matter shall be returned to the Commission for deliberation. Members of the public shall not be entitled to participate in that deliberation, or be present at the podium during such deliberation, except at the invitation of the Commission for a point of clarification or question by the Commission.

Individual Commission members may ask clarifying questions but will not engage in substantive dialogue with persons providing input to the Commission.

If a person providing input to the Commission creates a disruption by refusing to follow Commission guidelines, the Chair of the Commission may take the following actions:

Step 1. Request the person adhere to the Commission guidelines. If the person refuses, the Chair may ask the Clerk to turn off the speaker's microphone.

Step 2. If the disruption continues, the Chair may order a recess of the Commission meeting. Step 3. If the disruption continues, the Chair may order the removal of the person from the

Hearing to consider CUP22-0013/Black Oak Mountain Winery submitted by Curtis Van Winkle, for a Conditional Use Permit to allow up to 165 Special Events per year. The property, identified by Assessor's Parcel Number 074-042-002 (Exhibit C), consisting of 146.52 acres, is located on the south side of State Highway 193, approximately 0.25 mile east of the intersection with Brush N Rocks Lane, in the Cool area (Exhibits A and B); Staff recommends the Planning Commission take one of the following actions:

- A) 1. Direct staff to prepare a Negative Declaration based on an Initial Study prepared by staff; or
- B) 1. Find the project Categorically Exempt under Section 15301 of the CEQA Guidelines (Exhibit L); and
- 2. Approve Conditional Use Permit CUP22-0013 based on Findings to be made by the Planning Commission and subject to the Conditions of Approval as presented; or
- C. 1. Find the project Statutorily Exempt under Section 15270 of the CEQA Guidelines (Exhibit L); and
- 2. Deny Conditional Use Permit CUP22-0013. (Supervisorial District 4)

Chair Williams opened the hearing. Chair Williams disclosed that he visited the site and met with some of the neighbors; Commissioner Frega disclosed that he visited the site and spoke with the applicant, their advisor, and a neighbor; Commissioner Costello disclosed that he visited the site and met with neighbors; Commissioner Hansen disclosed that he received messages; and Commissioner Spaur disclosed that he had a meeting with the applicant's advisors.

Upon hearing from staff and the public, Chair Williams closed the hearing. A motion was made by Commissioner Costello, seconded by Chair Williams, to adopt the findings as presented by staff and deny CUP22-0013/Black Oak Mountain Winery.

Note: Commissioner Frega expressed disagreement with the findings, noting that the definition distinguishing agricultural versus commercial use needs clarification. Without this clarity, he could not vote to deny the application.
