The recent Village Life edition included a statement from Supervisor Shiva Frentzen, in which she'd asserted that a meeting for the Central EDH project be held in El Dorado Hills. Without consideration for whether or not the newspaper reported the statement correctly, the District finds that notion to be a superb idea. Doing this would be the sort of public outreach which builds confidence in the processes carried out by local government.

The District is extending an offer for use of the Pavilion and/or Gymnasium to host that meeting, gratis, with there only needing to be scheduling coordinated. Such a meeting could quite possibly be hosted in the evening and/or weekend, to afford interested residents the opportunity to participate in this important process.
