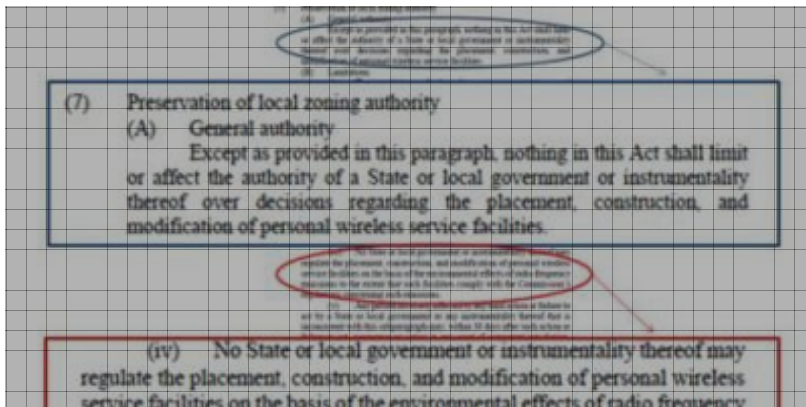

I am writing to request a negative vote on the proposed project for construction of an AT&T Mobility facility to be constructed at Snows Rd. and Clouds Rest Rd. in the Newtown Area. I have never considered myself an alarmist, but the more data I read concerning exposure to Low Intensity Electromagnetic Radiation, the more worried I become for the potential exposure of all of us within 1000 meters of the site. After reading reports and scientific papers, and seeing the growing body of evidence that points to increased risks of a number of neurological problems, and increased cancer risks to humans in close proximity to Cell Tower Sites, I implore you to do your due diligence to protect us from this impending disaster. Many studies have produced undeniable results of EMR as a health risk, and the World Health Organization has classified radiofrequency electromagnetic fields as a carcinogen in the same category as lead, DDT, and asbestos, and vehicular exhaust. Several years the FCC approved funding for new cell towers to be constructed in rural areas. The purpose of these towers is to bring high speed Internet and cell service to areas that have little or no coverage.

There are approximately 30+ towers presently being submitted to the El Dorado County Planning Department. One of the towers that has already been submitted and has been approved by the planning commissioners is the Tiger Lily tower which will service the Victory Mine, Big Cut, Cedar Ravine, Oak Hill and Pleasant Valley road areas and beyond.

Although the planning commissioners approved the tower two weeks ago this decision was appealed by one person to the Board of Supervisors. This appeal will be heard on February 13th at 3 PM at the Board of Supervisors hearing room.

I received a phone call yesterday by a representative from AT&T who told me that they were informed by the El Dorado planning department that there have been emails in favor of the tower from the Oak Hill and Twitchell Road area. Of course, the person who has appealed the planning commissioners approval of the tower has been drumming up a lot of people from outside of our area to write emails as well.

I have had the opportunity to speak to many people in our area and surprisingly I have been receiving some phone calls from people wanting to know the status of the Tiger Lily tower. Everyone that I've talked to on our road is excited about high-speed Internet and better cell service.

I would appreciate if you could send an email to the board of supervisors and to Evan Mattes from the planning department simply stating that you are in favor of the Tiger Lily cell tower project.
