To the Clerk of the Board and the Board of Supervisors,

I am incensed that someone who does not hold those minimum human values "represents" me, and come next election cycle will volunteer to campaign for individuals who DO hold those values. I am very sad that I did campaign in the past for one Board member who apparently does not.

All,

I really don't understand why this board would want to disband this commission in this way. None of it makes any sense to me, other than possibly political pressure from the same people who are feeling picked on for getting called out for their association with a local group that has chosen to take on the name of a national hate group.

Things were said in the January meeting where staff was asked to come back with a resolution disbanding the commission that are either not true or not thought through.

The complaint that the HRC intended to reach out to a local native American group with which the county has a liaison neglects to mention that one of the supervisors on the commission suggested they do so. Do our supervisors not talk to one another?

The comment that the HRC has done nothing over the last 4 years, not true. Granted, while they were disbanded because of Covid, they were forced to be inactive. But in addition to last year's homeless forum, which was very well done, they have had presentations every month (Native American month, for example), and a very successful public Human Right's forum in 2019.

The board wants to replace the commission with a non-profit, but has done nothing to reach out to the non-profit that was mentioned to see if it is even feasible to transition this function.

It was stated that two supervisors were needed on the commission, and we have two supervisors who are willing to do so.

The commission was not given the opportunity to respond to any of the objections that were mentioned in the January meeting.

The county needs this commission. From racial slurs painted on the Sleepy Hollow bridge a few years ago, to the very recent lawsuit against EDUHSD by a student who experienced terrible treatment at one of our local high schools, to the truly mean and heartless remarks people have made about our homeless neighbors, it is truly apparent that the time to do away with this commission is not yet, or any time soon.

This is not a step forward. It is a step backwards. Disbanding this commission tells the people who have tagged that bridge, harassed that student, maligned all homeless people as druggies, etc. that what they are doing is OK. Please don't do this.
