On or about September 22, 2011 the County of EI Dorado wII submit a reguest to the Californa Deparment of Housing and Community Development (MCD) for the release of Home Investment Partrershp Program (HOME) funds under The II of the Cranston-Conzales National Affordatse Mlousing Act of 1990 as amenced to underake a project known as the Fist Time Homebuyer Prograxe, Acquistion with Minor fehabiliation of single family dwellngs. The proiect, wit utize zo10 HOME lunds, fulure HOME finds, HOME Program Income, CDBG Fevoluing Loan Funds, and any other source of federal, Slate and local funds as they may become avallable during the program term trom date of approval Iof a period of lye years. The approximate amount of these funds may potentally reath \$4 500 000, of wheh the maximum amount of HOME tunds may be an estimated naximum of \$2,500,000. ## RELEASE OF FUNDS

The County of FI Dorado certifies to HCD that Danlel Nielson, M. (c) the grant recipient or other participants in the project have committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by the Callformia Department of HCD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental qually. Objections must be prepared and submitted in accordance with the required procedures ( 24 CFF Part 58) and shall be addressed to the Department of Housing and Community Development, HOME Program, 1800 Third Street, MS 390-3, Sacramento. CA 95814 . Polential objectors should contaci HCD to verify the actual last day of the objection period.
