

AGREEMENT FOR SERVICES #411-S1411  
AMENDMENT I

This Amendment I to that Agreement for Services #411-S1411, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and El Dorado County Office of Education (EDCOE), Adult Education Program, a public education entity, whose principal place of business is 6767 Green Valley Road, Placerville, CA 95667; (hereinafter referred to as "Contractor");

**RECITALS**

**WHEREAS**, Contractor has been engaged by County to provide Assembly Bill 109 enhanced educational services to the Placerville and South Lake Tahoe El Dorado County Jail facilities and El Dorado County Community Corrections Center (CCC) as established in the Public Safety Realignment Plan/Community Corrections Partnership, in accordance with Agreement for Services #411-S1411, dated March 18, 2014, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to include Exhibit "E" marked "El Dorado County Office of Education and El Dorado County Jail, South Lake Tahoe Adult Education Jail Program Expenditure Budget 7/1/2013 through 2/28/2014", hereby amending **Article I – Scope of Services**; and **Article III – Compensation for Services**.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #411-S1411 shall be amended a first time as follows:

ARTICLES I and III are amended in their entirety to read as follows:

**ARTICLE I**

**Scope of Services:** Services for the El Dorado County Jail facilities shall be in accordance with Exhibit "A" to the original Agreement and Services for the El Dorado County Community Corrections Center shall be in accordance with Exhibit "B" to the original Agreement. All services shall be in accordance with Exhibit "C" to the original Agreement.

For the period of July 1, 2013 through February 28, 2014, the Contractor agrees to provide an inmate education program per Title 15, Section 1061 of the California Code of Regulations for the Sheriff's Office. Services may include, but not be limited to, Adult Education Program design, the provision of one (1) part time teacher, and administrative support. Classes provided will include a G.E.D (General Education Development Test) class, Employment Success/Reentry class and an ESL (English as a second language) class. Services shall be in accordance with Exhibit "E," marked "El Dorado County Office of Education and El Dorado County Jail, South Lake Tahoe

Adult Education Jail Program Expenditure Budget 7/1/2013 through 2/28/2014,” incorporated herein and made by reference a part hereof.

**ARTICLE III**

**Compensation for Services:** For services provided herein, County agrees to pay Contractor monthly in arrears and within forty-five (45) days following the County’s receipt and approval of itemized invoice(s) identifying services rendered. For the purposes of this Agreement, the billing rate shall be in accordance with Exhibit “D” to the original Agreement.

For the period of July 1, 2013 through February 28, 2014, the billing rate for the South Lake Tahoe Adult Education Jail Program Expenditure Budget shall be calculated in accordance with Exhibit “E.”

Funding for this agreement is approved by the Community Corrections Partnership (CCP) Executive Committee on an annual basis. Should the CCP Executive Committee, during the course of a given year for financial reasons reduce, or order a reduction, in the funding for services provided under this agreement, pursuant to this paragraph in the sole discretion of the County, this agreement may be deemed to be canceled in its entirety subject to payment for services performed prior to cancellation.


