

Terms of Donation Acceptance by
County of El Dorado

I, Clifford J. Wadiak, on behalf of myself, my heirs, successors, and assigns (collectively, "Donor") do hereby voluntarily donate the following to the County of El Dorado ("County"):

(1) Funds in the amount of Thirteen Thousand Five Hundred Sixty Dollars (\$13,560) for the construction of a private office space at the Veterans Office Building located at 130 Placerville Drive, Suite B, Placerville, CA 95667 ("Donated Funds"). The office space is intended to be occupied by the Veteran Services Office for 'Better Serving Community Veterans' ("Office Space"); and

(2) A brass plaque to be installed at the Office Space commemorating Don W. Harr with the following inscription: "This VSO office was a donation "To Better Serve the Veterans of El Dorado County" from the Wadiak family of El Dorado Hills, and the VA. It is a tribute to USN Veteran, Aviation Boatswains Mate Don W. Harr that honorably served his country aboard the aircraft carrier USS Bon Homme Richard, CVA-31" ("Plaque").

Don W. Harr is a recognized veteran of the United States Navy at the County's Veterans Monument and has met the County's Veterans Monument Criteria requirements for recognition.

Donor does hereby acknowledge and agree to the following terms and conditions of the County of El Dorado's acceptance of the Donated Funds and Plaque:

1. ~~County will use the Donated Funds to construct improvements for the Office Space.~~
County is under no obligation to complete this project within a specified period of time. Once completed, County will maintain the Office Space.
2. County will install and maintain the Plaque.
3. ~~County is not required to use the Office Space for any specified period of time and~~
may freely, within the County's sole discretion, terminate said use at any time.
4. In the event County determines to cease to use the Office Space, the Plaque will be removed in County's sole discretion. Upon removal of the Plaque, County will notify Donor of the removal and desire to return the Plaque to Donor. If Donor does not respond to County within 35 calendar days of the delivered notification, County may dispose of the Plaque as County sees fit in its sole discretion, which may include, donation or use for another purpose, destruction, or disposal. Notification is deemed delivered when deposited into the United States Postal Service mail.
