The County of El Dorado Board of Supervisors will hold a public hearing in the Supervisors Meeting Room, 330 Fair Lane, Placerville, CA 95667 on October 18, 2011, at 2:00 p.m., to consider Rezone Z11-0008/Barnett Business Park submitted by EL DORADO COUNTY to rezone three adjoining parcels in the Barnett Business Park from Professional Office Commercial-Design Community (CPO-DC) to General Commercial-Design Community (CG-DC). The property, identified by Assessor's Parcel Numbers 109-401-02, 109-401-03, and 109-401-04, consisting of 5.55 acres, is located on the north side of Trade Way, between the intersections with Business and Product Drives, in the Shingle Springs area, Supervisorial District 2.
