# SIXTH AMENDMENT TO AGREEMENT TO MAKE SUBDIVISION IMPROVEMENTS FOR CLASS 1 SUBDIVISION BETWEEN COUNTY AND OWNER

THIS SIXTH AMENDMENT, to that certain Agreement to Make Subdivision Improvements for Class 1 Subdivision Between County and Owner (hereinafter referred to as the "Agreement"), made and entered by and between the COUNTY OF EL DORADO, a political subdivision of the State of California, (hereinafter referred to as "County"), and LENNAR HOMES OF CALIFORNIA, LLC, a California Limited Liability Company, duly qualified to conduct business in the State of California, whose principal place of business is 1025 Creekside Ridge Drive, Suite 240, Roseville, California 95678 (hereinafter referred to as "Owner"); concerning HAWK VIEW – UNIT 1, TM 00-1371-R/TM 00-1371-E (hereinafter referred to as "Subdivision"); the Final Map of which was filed with the El Dorado County Board of Supervisors on the 9<sup>th</sup> day of October, 2018.

#### RECITALS

WHEREAS, County, and Owner entered into that certain Subdivision Improvements Agreement on October 9, 2018, entered into the First Amendment to the Agreement on August 17, 2020, entered into the Second Amendment to the Agreement on September 28, 2021, entered into the Third Amendment to the Agreement on September 23, 2022, entered into the Fourth Amendment to the Agreement on September 18, 2023, and entered into the Fifth Amendment to the Agreement on September 30, 2024, in connection with the Subdivision, copy of which Agreement, First Amendment, Second Amendment, Third Amendment, Fourth Amendment, and Fifth Amendment are incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the Agreement, as amended, requires Owner to complete the subdivision improvements thereunder on or before October 9, 2025, and Owner has not completed all of the improvements but has requested an extension of time to complete the subdivision improvements on or before October 9, 2026, subject to the terms and conditions contained herein;

**NOW, THEREFORE**, the parties hereto, in consideration of the recitals, terms, and conditions herein, do hereby agree to amend the terms of the Agreement in this Fifth Amendment to read as follows:

- I. Section 3 is hereby amended to read as follows:
  - 3. Complete the Subdivision improvements contemplated under this Agreement on or before October 9, 2026.

Except as herein amended, all other parts and sections of that certain Agreement dated October 9, 2018, shall remain unchanged and in full force and effect.
