**RESOLUTION OF VACATION**  
**Abandonment of Easement #08-0007**  
**The Promontory Village No. 6, Unit 2A, Lots 82 and 84**  
**Assessor's Parcel Numbers 124-130-19 and 124-130-54**  
**Derrek L. Lee and Christina Lee**

**WHEREAS**, the El Dorado County Board of Supervisors exercises the authority established by Section 8333 of the Streets and Highways Code, which authorizes the Board of Supervisors to summarily vacate public service easements by Resolution adopted in accordance with Section 8335 of the Streets and Highways code; and

**WHEREAS**, public utility easements, as shown on The Promontory Village No. 6, Unit 2A final map, were irrevocably offered in perpetuity to the County of El Dorado in August of 2002 and accepted by the Board of Supervisors in October of 2002; and

**WHEREAS**, the Department of Transportation has received an application from Derrek L. Lee and Christina Lee, owners of Lots 82 and 84 of The Promontory Village No. 6, Unit 2A, identified as Assessor's Parcel Numbers 124-130-19 and 124-130-54, requesting that the County of El Dorado vacate public utility easements located along the side boundary lines for Lot 82 and on the common side boundary line between Lot 82 and Lot 84; and

**WHEREAS**, A T & T, Comcast, El Dorado Irrigation District, and Pacific Gas & Electric have not used said easements for the purpose for which they were dedicated or acquired and find that no present or future need exists for said easements and do not object to their vacation; and

**WHEREAS**, all other existing easements will remain; and

**WHEREAS**, the Department of Transportation has determined that said easements herein described in Exhibit A and depicted in Exhibit B, have not been used for the purpose for which they were dedicated preceding the proposed vacation, and has no objection.

**NOW, THEREFORE BE IT RESOLVED**, that from and after the date this Resolution is recorded, said public utility easements described in Exhibit A and depicted in Exhibit B, and by reference are made a part hereof, are vacated and no longer constitute public utility easements. In addition, a Certificate of Correction is hereby authorized to be signed and may be recorded by the County Surveyor.
