

AGREEMENT FOR SERVICES 204-S1211
AMENDMENT I

THIS AMENDMENT I to that Agreement for Services 204-S1211, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Womenspace Unlimited, South Lake Tahoe Women's Center, Inc., a California non-profit public benefit corporation qualified as a tax exempt organization under Title 26 Code of Federal Regulations Section 1.501 (c) (3) commonly referred to as Section 501 (c) (3) of the Internal Revenue Code of 1986, whose principal place of business is 2941 Lake Tahoe Blvd., Suite A, South Lake Tahoe 96150 (hereinafter referred to as "Contractor"), and whose Agent for Service of Process is Aileen Yure, 2941 Lake Tahoe Blvd, South Lake Tahoe, 96150.

RECITALS

WHEREAS, Womenspace Unlimited, South Lake Tahoe Women's Center has been engaged by County to provide domestic violence services, in accordance with Agreement for Services 204-S1211, dated January 10, 2012, incorporated herein and made by reference a part hereof; and

WHEREAS, Womenspace Unlimited, South Lake Tahoe Women's Center, Inc., has legally changed their corporate name to Live Violence Free, Inc.; and

WHEREAS, the parties agree to amend the Agreement to reflect the corporate name change;

NOW THEREFORE, the parties do hereby agree that Agreement for 204-S1211 shall be amended a first time as follows:

1) ARTICLE III, Section 3.05 shall be amended in its entirety to read as follows:
