



RESOLUTION NO. 170-2020

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, an analysis of classifications allocated to represented and unrepresented bargaining units was conducted to ensure classifications within each unit share an identifiable community of interest consistent with the principles set forth in section 2.07 of the Employer-Employee Relations Resolution; and

WHEREAS, in accordance with Section 603 of the County of El Dorado Personnel Rules Resolution #018-2019 applicable to represented and unrepresented employees, and Section 601 of the El Dorado County Salary and Benefits Resolution #165-2020 applicable to unrepresented employees, the Board of Supervisors shall by Resolution establish the salary for all authorized positions within the County; and

WHEREAS, in accordance with Section 501 of the County of El Dorado Personnel Rules Resolution #018-2019 applicable to represented and unrepresented employees, at the recommendation of the Human Resources Department, the Board of Supervisors shall approve all new classes and class specifications, abolish classes, and determine the representation unit or units to which each class is assigned.

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of the County of El Dorado authorizes the Director of Human Resources to make any technical corrections if needed.

BE IT FURTHER RESOLVED, that the Board of Supervisors of the County of El Dorado does hereby adopt the revised salary ranges for the classifications as set forth herein, and amends the Salary Schedule, effective pay period 01 of calendar year 2021.

BE IT FURTHER RESOLVED, that the Board of Supervisors of the County of El Dorado does hereby adopt the bargaining unit changes and amends the Salary Schedule as set forth herein, effective pay period 01 of calendar year 2021.
