Recommendation:

Your Board is requested to authorize the Chair to sign Amendment #3 to the software license agreement with TracNet Corporation of Pacific Grove, California.

Reason for Recommendation:

The Sheriff's Office has received state funding to purchase software that will allow for wireless transmission of crime reports from patrol cars in the field, eliminating the need for officers to return to the main office to upload their reports and allowing supervisors to approve reports in the field during the course of a shift, rather than in the office at the end of a shift. In order to implement wireless technology, the in-field report writing system must be modified. The amendment before you today allows for that modification by TracNet Corporation, the supplier of the in-field report writing system.

Please note that the original software license with TracNet Corporation, approved by your Board on September 24, 1996, Amendment #1 approved by your Board on June 27,2000, and Amendment #2 approved by your Board on June 27, 2001 contained non-standard liability and insurance provisions. The amendment before you does not change that situation, as has been noted by both County Counsel and Risk Management in their review of the amendment. As was the case on those three prior occasions, the Sheriff's Office recommends that your Board note the concerns raised by County Counsel and Risk Management but authorize the Chair to sign the Amendment anyway.

Fiscal Impact:

None. \$40,000 is currently available in the Sheriff's FY 01-02 budget from the California Law Enforcement Technology Program grant for this modification.

Action to be Taken Following Approval:

The Chair will sign the Amendment and Purchasing will encumber the grant funds.

SUBJECT: Amendment #3 to the TracNet Software License Agreement

The software license agreement with TracNet Corporation, signed in September 1996 contains non-standard indemnification and insurance language. The same is true of Amendment #1 signed in May 1999 and Amendment #2 signed in June 2001. County Counsel and Risk Management recommended that the Board not sign the original license agreement as well as the two amendments because of the non-standard features of the agreement. The Sheriff's Office noted those recommendations in taking the documents to the Board, but recommended that they Board sign and they did.

As Amendment #3 was negotiated, my staff and I did discuss whether TracNet was now willing to accept the County's standard language, but they are not. We expect that stance will cause both County Counsel and Risk Management to renew their previous objections.

Given our long-standing, trouble-free relationship with TracNet and our inability to purchase the enhancement provided for by this amendment elsewhere given the proprietary nature of the software, the Sheriff's Office will recommend to the Board that it sign the amendment but will note your expected objections in the agenda item.

Grant funds are paying for the enhancements provided for by this amendment and must be encumbered prior to June 30, 2002. We would like to have this item on the Board's June 11th agenda it possible, so your prompt preparation of your objections would be appreciated. I have attached copies of the original agreement and the two earlier amendments, as well as the comments you prepared after reviewing Amendment #2, to assist you with this review. SUBJECT: Amendment #3 to Software License with TracNet Corportation

I have reviewed the comments you made on the Contract Routing Sheet and would offer the following additional information:

- Review of this amendment by Information Services would be inappropriate. The Sheriff's Office has a separate technology section responsible for all its unique software programs. Information Services has no involvement with those programs and so a review would be meaningless.
- 2. We believe the letter from TracNet that is incorporated as a part of the amendment sufficiently describes the wireless CAD status and server software code and that no additional documentation is required.
- 3. As additional modules are purchased from TracNet, additional maintenance charges are imposed. "Upgrade" refers to the additional maintenance charge to be imposed for the wireless application being purchased via this amendment.
- 4. We recognize County Counsel's continued objection to the non-standard indemnification language and the use of something other than the County's standard contract agreement. However, the Sheriff's Office has done business with TracNet for six years and has never experienced any problems with them because of the unique nature of the software license. We will include your memo of June 7, 2001 that detailed those objections when Amendment #2 went to the Board with this agenda item.

Your prompt review of this amendment was appreciated.
