THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS:

RELATED TO REZONING IN THE EL DORADO HILLS AREA (Wilson Estates)

Section 1. The Official Zoning Map for the El Dorado Hills area is hereby amended to rezone the following described lands as shown on Exhibit A hereto:

From: One-Acre Residential (R1A)

To: One-Acre Residential-Planned Development (R1A-PD) and Open Space-Planned Development (OS-PD)

El Dorado Hills Area

Assessor's Parcel Nos. 126-070-22, 126-070-23, and 126-070-30, being described as a portion Section 23, T10N, R8E, M.D.M., consisting of 28.16 acres.

Section 2. This ordinance shall take effect and shall become effective thirty (30) days following the adoption hereof.
