

SECOND AMENDMENT TO AGREEMENT FOR SERVICES #3958

**THIS SECOND AMENDMENT** to that Agreement for Services #3958 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Dominion Voting System, Inc., a Delaware corporation duly qualified to conduct business in the State of California, whose address is PO Box 343, Broomfield, CO 80038 (hereinafter referred to as "Contractor");

**RECITALS**

**WHEREAS**, on July 17, 2019, the County and Dominion entered into an Agreement for Services (the "Original Agreement"); incorporated herein and made by reference a part hereof;

**WHEREAS**, August 25, 2020, the County and Dominion entered into a First Amendment to the Agreement for Services, an addendum herein referred to as ("First Amendment") (collectively the Original Agreement and First Amendment are referred to herein as the "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to extend the expiration date of June 30, 2024, for three (3) additional years, amending **ARTICLE II, Term**;

**WHEREAS**, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement to \$1,200,000.00, including all applicable charges, shipping, taxes, and fees, and to include a new fee schedule for the extended term of the Agreement, amending **ARTICLE III, Compensation for Services**, and adding **Amended Exhibit C-2**;

**WHEREAS**, the parties hereto desire to replace Exhibit C (the "Original Agreement") and Exhibit C-1 ("First Amendment") with new Exhibit C-2 containing all ongoing annual license and warranty fees. The parties agree that all other amounts due pursuant to Exhibit C and Exhibit C-1 have been paid prior to the execution of this Second Amendment.

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this second Amendment to Agreement on the following terms and conditions:

I. **ARTICLE II, Term**, of the Agreement is amended in its entirety to read as follows:

**ARTICLE II**

**Term:** This Agreement shall become effective when fully executed by the parties hereto and shall expire on June 30, 2027.

II. **ARTICLE III, Compensation for Services**, of the Agreement is amended in its

entirety to read as follows:

### **ARTICLE III**

**Compensation for Services:** For services provided herein, County agrees to pay Contractor within forty-five (45) days following County receipt and approval of itemized invoices detailing the services rendered.

For the purposes hereof, for the period beginning with the effective date of this Agreement and continuing until the day before the effective date of this Second Amendment to the Agreement, the billing rates shall be in accordance with Exhibit C and Exhibit C-1, marked "**PRICING SUMMARY AND DELIVERABLES DESCRIPTION**" incorporated herein and made by reference a part hereof.

For the period beginning with the effective date of this Amendment and continuing through the remaining term of the Agreement, the billing rates shall be in accordance with Amended Exhibit C-2, marked "**PRICING SUMMARY AND DELIVERABLES DESCRIPTION,**" incorporated herein and made by reference a part hereof.

The total amount of this Agreement, as amended, shall not exceed \$1,200,000.00, inclusive of all costs and expenses.

Itemized invoices shall follow the format specified by County and shall reference this Agreement number on their faces. Copies of documentation attached to invoices shall reflect Contractor's charges for the specific services billed on those invoices. Invoices shall be mailed to County at the following address:

or to such other location as County directs.

In the event that Contractor fails to deliver, in the format specified, the deliverables required by this Agreement, County at its sole option may delay the monthly payment for the period of time of the delay, cease all payments until such time as the required deliverables are received, or proceed as set forth below in ARTICLE XIV, Default, Termination, and Cancellation, herein.

Pursuant to Government Code section 84308 (SB 1439, the Levine Act), Contractor shall complete and sign the attached Exhibit D, marked "California Levine Act Statement," incorporated herein and made by reference a part hereof, regarding campaign contributions by Contractor, if any, to any officer of County.

Except as herein amended, all other parts and sections of Agreement for Services #3958 shall remain unchanged and in full force and effect.

**California Levine Act Statement**

**California Levine Act Statement**

California Government Code section 84308, commonly referred to as the "Levine Act," prohibits any officer of El Dorado County from participating in any action related to a contract if he or she accepts, solicits, or directs any political contributions totaling more than two hundred and fifty dollars (\$250) within the previous twelve (12) months, and for twelve (12) months following the date a final decision concerning the contract has been made, from the person or company awarded the contract. The Levine Act also requires disclosure of such contribution by a party to be awarded a specific contract. An officer of El Dorado County includes the Board of Supervisors, any elected official, and the chief administrative officer (collectively "Officer"). It is the Contractor's responsibility to confirm the appropriate "Officer" and name the individual(s) in their disclosure.
