

George Orwell said, “*During times of universal deceit, telling the truth becomes a revolutionary act.*”

Community organizing is most identified with the left-wing Chicago activist Saul Alinsky who pretty much defined the profession. In his classic book, ***Rules for Radicals***, Alinsky wrote that a successful organizer should be “*an abrasive agent to rub raw the resentments of the people of the community; to fan latent hostilities of many of the people to the point of overt expressions.*” Once such hostilities were whipped up into a frenzy, the organizer steered his group toward confrontation and general hell-raising. In September of 2018 the Steering Committee sent me an email that reads in part:

members asking that your behavior be stopped. We will be writing a separate email to the group and to list administrator Mike Bean to inform them of this decision."

The truth is I did NOT hammer, criticize or complain about anyone. Three times I appropriately requested the Fire Safe Committee post information on CLNews for neighbors to obtain the **Right of Entry Consent** forms in order to participate in a CL Fire Safe grant-funded project last September. And I spoke the truth when I stated that Mike Ranalli was unresponsive to our public safety concerns. The River Mafia Mob deceitfully twisted my intent and retaliated against me **for asking to be provided the necessary Fire Safe information!**

It was Justice William O. Douglas who affirmed the right of Americans to speak softly or angrily to government officials, **even if our words challenge and annoy**. Melody,

Your three messages to the CL News group, sent September 2 and September 7, 2018, were in violation of the CL News Guidelines that were posted to the list and also shared with you directly in August. As a result, the CL News Steering Committee has voted to suspend your posting privileges for CL News for six months. During this time you will be able to read messages from the list but will be unable to post to the list.

The CL News Guidelines, which are posted at <https://groups.google.com/d/msg/clnews/VU6Goo6gfGo/Eye3qHt1BQAJ>, state:

"CL News is also NOT to be used to post negative comments or commentaries about people, whether they are inside or outside the community. Calling people derogatory names has no place on the list. Turning a conversation on the list into an attack on another group member is the quickest way to be removed from the list."

Your messages criticized the volunteers on the local Coloma Lotus Fire Safe Council, as well as the EDC Fire Safe Council, the project manager, and Supervisor Ranalli, along with multiple complaints aimed at no specific party. If you have criticisms, they should be directed at the specific individuals or groups, not to the list. If you had posted just one message, it might have been ignored, but multiple messages hammering on local parties could not be tolerated. We received numerous complaints from list members asking that your behavior be stopped.

This is your second infraction. After the six months you will be reinstated but you will still be on probation. A third infraction will result in complete removal from CL News for a 12 month period. After 12 months, you may petition the Steering Committee in writing to be reinstated. Reinstatement is not guaranteed, & each situation will be reviewed individually.

We will be writing a separate email to the group and to list administrator Mike Bean to inform them of this decision.

You are welcome to reply to this message if you do not understand why, or would like to express an opinion about the Guidelines or this decision. Please be polite.

ADOPTION RESOLUTION
EL DORADO COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN

WHEREAS, Congress directed the Federal Emergency Management Agency (FEMA) to place more emphasis on the planning process to promote and support sustainable, disaster resistant communities; and,

WHEREAS, The Disaster Mitigation Act of 2000 ((DMA 2000) amended the Robert T. Stafford Disaster Relief and Emergency Assistance Act by adding a new section, 322-Mitigation Planning. Mitigation is defined as sustained action taken to reduce or eliminate long-term risk to people and their property from hazards and their effects" and;

WHEREAS, effective November 1, 2004, a mitigation plan approved by FEMA and the State is required from any community that wishes to obtain federal mitigation grant funding to reduce or eliminate potential risk to people and their property from hazards and their effects; *where does \$ go? Accountability*

WHEREAS, the County of El Dorado is desirous of increasing the safety of its citizens during natural hazard events, while reducing the risk of loss of life and property;

WHEREAS, the County of El Dorado seeks to secure all the benefits of mitigation planning, including the full allocation provided under Government Code Section 8685.9;

NOW THEREFORE, BE IT RESOLVED that the El Dorado County Board of Supervisors has reviewed the Multi-Jurisdictional Hazard Mitigation Plan approved by FEMA and hereby adopts the same, with all subsequent amendments required or approved by FEMA, as the El Dorado County Multi-Jurisdictional Hazard Mitigation Plan.

BE IT FURTHER RESOLVED that the El Dorado County Board of Supervisors adopts the FEMA approved El Dorado County Multi-Jurisdictional Hazard Mitigation Plan as part of the Safety Element of the General Plan adopted pursuant to subdivision (g) of Government Code Section 65302.
