FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING #9537

THIS FIRST AMENDMENT to that Memorandum of Understanding #9537 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "Sponsor"), and State of California Department of Forestry and Fire Protection (hereinafter referred to as "CAL FIRE").

RECITALS

WHEREAS, CAL FIRE has been engaged by Sponsor to utilize inmates, or wards, in the performance of conservation projects, fuels management and/or hazard reduction to perform the work of CAL FIRE pursuant to Memorandum of Understanding #9537, dated August 28, 2025, incorporated herein and made by reference a part hereof (hereinafter referred to as "MOU");

WHEREAS, the parties hereto desire to amend the MOU for a retroactive term date beginning July 1, 2025, amending **Section O**;

WHEREAS, the parties hereto desire to amend the MOU to update the operational cost recovery from sponsor to include a new administrative rate, amending OPERATIONAL COST RECOVERY FROM SPONSOR;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, Sponsor and CAL FIRE mutually agree to amend the terms of the MOU in this First Amendment to Memorandum of Understanding #9537 on the following terms and conditions:

- **Section O,** of the MOU is amended in its entirety to read as follows:
 - **Section O.** This MOU shall be effective upon execution and shall cover the period of July 1, 2025, through June 30, 2026, unless terminated prior to that date by sixty (60) calendar days written notice from one party to the other.
- II. OPERATIONAL COST RECOVERY FROM SPONSOR, of the MOU is amended in its entirety to read as follows:

Total \$394.32/day per work crew (plus current F/Y administrative fee) Weed eater \$20.16/day Track Chipper \$551/day Trailer Chipper \$432.88/day Total \$394.32/day per work administrative Rate 11.88% If Applicable If Applicable Trailer Chipper \$432.88/day

Except as herein amended, all other parts and sections of Memorandum of Understanding #9537 shall remain unchanged and in full force and effect.
