Since Volatile Organic Compounds (VOC) emissions are precursors to ozone formation, one of the strategies to control ozone pollution is to reduce VOC emissions from existing stationary sources. On October 26, 2007, the California Air Resources Board (CARB) adopted a Suggested Control Measure (SCM) for architectural coatings. The purpose of the SCM is to promote uniformity among district rules, improve enforceability, and achieve additional reductions of VOC emissions from the application of architectural coatings.

Rule 215 limits the emissions of VOCs from the use of architectural coatings (paints). To achieve further emissions reductions, in June 2017, the AQMD amended Rule 215 to incorporate the requirements of the 2007 SCM. Although the 2017 amendment was reviewed and approved by United States Environmental Protection Agency (EPA) Region 9 staff in 2017, upon further review in 2019, EPA staff determined that there were slight language differences between the 2007 SCM and Rule 215. AQMD staff is now proposing a minor revision to Rule 215 to correct the language differences.

The VOC content limits in proposed revised Rule 215 are the same and are not stricter than those found in the SCM. The other air districts within the Sacramento Federal Ozone Nonattainment Area: Sacramento Metropolitan; Placer County; Yolo-Solano; and Feather River air districts; have all revised their architectural coatings rules to be consistent with the SCM.

AQMD staff is now proposing a minor revision to the Rule 215 to correct the language differences.
