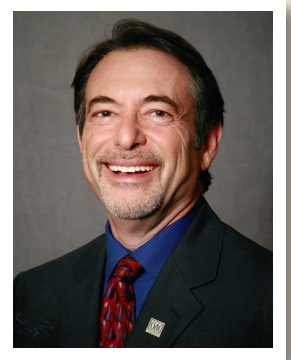


# WELCOME

## Tuesday Kick-Off Session Speaker



### Dan Buettner Author of Blue Zones

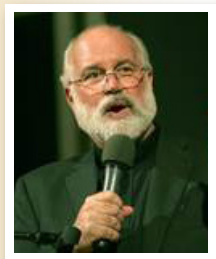
Dan Buettner is an internationally recognized researcher, explorer, New York Times best-selling author, and National Geographic Fellow. He founded Blue Zones®, a company that puts the world's best practices in longevity and well-being to work in people's lives.

Mr. Buettner's colossal research effort, funded in part by the National Geographic Expeditions Council and the National Institute on Aging, has taken him from Costa Rica to Italy to Japan and beyond. He has discovered that the way people interact with each other, nourish their bodies, and view their world impacts the extent and quality of their lives.

Mr. Buettner's National Geographic cover story on longevity, "The Secrets of Living Longer", was one of the magazine's top-selling issues in history and a made him a finalist for a "National Magazine Award." His books *The Blue Zones: Lessons for Living Longer From the People Who've Lived the Longest* (2008) and *Thrive: Finding Happiness the Blue Zones Way* (2010) appeared on many best seller lists and were both featured on Oprah.

In 2009, Mr. Buettner and his partner, AARP, applied principles of The Blue Zones to Albert Lea, Minnesota, and successfully raised life expectancy and lowered health care costs by some 40 percent. He's currently working with Healthways to implement the program in the Beach Cities of Los Angeles and the entire state of Iowa. Their strategy focuses on optimizing the health environment instead of individual behavior change.

## Thursday Luncheon Speaker



### Father Greg Boyle Founder & Executive Director, Homeboy Industries

Father Boyle is the founder and Executive Director of Homeboy Industries, the largest gang intervention, rehabilitation and re-entry program in the United States, now in its 25th year.

His dedication to finding a place for all in our society brought him to the Boyle Heights community of East Los Angeles, where he served as pastor of Dolores Mission Church, from 1986 through 1992. It was there that Father Greg started what would become Homeboy Industries, a nonprofit organization that employs and trains more than 300 former gang-members every year in seven social enterprises.

Homeboy Industries also provides critical services to the 12,000 people who walk through the doors every year seeking a better life. Father Greg is the author of the NY Times bestselling book *Tattoos on the Heart: The Power of Boundless Compassion*.

## **CSAC Innovation Summit – Blue Counties, Green Counties, Healthy, Sustainable**

Continued population growth, an aging population and a struggling economy have stretched the fiscal and natural resources of counties to the limit. County officials in partnerships with the private sector are taking new and creative approaches to provide services, and to continue to provide an improved quality of life for Californians.

This year, the Innovation Summit will highlight these innovations in two areas. First, we will explore a variety of sustainable activities, ranging from reducing greenhouse gas emissions, energy, water and fuel cost savings, and improving health and resilience to climate change.

Second, we will explore the impact of an aging population on county economies, including health care systems. Innovative strategies and best practices that strive to ensure a healthy and invigorating future for all Californians will be presented.

Finally, we will have a demonstration of a national project which allows counties to share best practices and innovations.

## **Exploring Gang Violence Prevention Strategies**

The problem of gang violence permeates many California communities at a significant societal cost – for the gang members, their families and the public at large. This workshop will focus on community intervention and prevention strategies, including examples of county efforts to address this problem – particularly those that seek to prevent involvement of at-risk youth in the gang culture.

## **Water Dialogue Part II**

With California facing one of the most severe droughts on record, focus on water has been at the forefront of discussions this year within the Legislature and across the state. Law makers have been grappling with issues related to sustainable and reliable water supply, water quality and the management of our watersheds and groundwater resources, along with the myriad of issues that threaten the health of our Delta. This workshop will feature regional perspectives from elected officials, as well as water suppliers and other stakeholders on key topics including, forest management and water quality, groundwater management and delta sustainability. Join us for this workshop and weigh in on a historic issue that will impact every Californian.

## **How Are Counties Preparing for California's Silver Tsunami?**

The number of Californians over age 65 is anticipated to double – to 8.4 million – by 2030. Presenters will discuss how counties are preparing for the rise in seniors residing in California and the policy and planning implications.

## **Affordable Care Act – Lessons from 2014**

As the first year of the Affordable Care Act implementation nears its close, a panel of experts including health plans and providers will reflect on the successes and challenges and look to the future of health care in California.

## **Sustainability**

Sustainability – it's not just the latest buzz word, but a new way of doing business. Come and learn how local governments and area businesses are promoting sustainable communities – places that foster and maintain a high quality of life for their residents on an ongoing basis by conserving resources, and operating so that that we have and will continue to have, the water, materials, and resources to protect human health and our environment.

## **The Poverty of Working Families in California – The Effect on California's Economy: The Shriver Report**

The most common shared story in our country today is the financial insecurity of American families. Today, more than one in three Americans – more than 100 million people – live in poverty or on the edge of it. *The Shriver Report, a Woman's Nation Pushes Back from the Brink*, reveals this national crisis through the eyes of women. Karen Skelton, CEO and Editor in Chief of the last three Shriver reports will discuss this most recent report and highlight the HBO documentary, *Paycheck to Paycheck the Life and Times of Katrina Gilbert*.

## **Promoting Effective Relationships with Tribal Governments**

California is home to 109 federally-recognized tribes – a greater number than any other state. Counties, due in part to the rural location of many present-day tribal lands, frequently interact with tribal governments in the course of carrying out their broad array of service responsibilities. This workshop will discuss models of effective government-to-government relationships between local governments and tribes and provide insight into methods to increase collaboration to the benefit of communities served by tribal and county governments.

## **Exploring a Road User Charge: Understanding the Fundamentals**

Funding for transportation infrastructure in California is woefully inadequate and getting worse. The 2012 California Statewide Local Streets and Roads Needs Assessment Report found an \$8.2 billion annual funding shortfall for just the maintenance and preservation of the existing local transportation network. The traditional funding mechanism – the gas tax – is no longer a sufficient tool for charging road users their fair share. Other states have begun to explore the potential for a road user charge (RUC) to replace the gas tax. Come listen to experts in the field discuss these issues and more as California begins to explore new funding mechanisms.

## **Art and Practice of Elected Leadership**

Leadership is a term you hear a lot, but as an elected official, how do you practice it? This course addresses the realities of leading in a turbulent political and economic environment. This timely course draws on the insights of Jim Collins' most recent book, *Great by Choice*, as well as a three-year research project on leadership and fiscal sustainability conducted by instructor Rich Callahan. The class is designed to initially invite discussion by the elected officials on the leadership challenges they have or are encountering. The course then specifically responds to those items, applying the research and empirical findings across a range of recent public sector and business sector leadership research.

***Instructor: Dr. Richard Callahan is Associate Professor of Management at the University of San Francisco. He brings practical experience researching and working with elected officials in leadership practices.***

## **Thinking Strategically in Trying Times**

This intense seminar discusses the challenges of strategic agility with the critical, enduring problems counties face. The focus is on the art of possibilities. Participants examine separating probabilities (what's likely to happen) from possibilities (what could happen) and applying concepts of creative and strategic thinking to find different paths to solutions. The conversation provides strategies to question assumptions, identify the environmental issues, distinguish strategies from tactics, use team resources, and structure learning from experience.

## HOTEL CANCELLATION, REFUND POLICY AND EARLY DEPARTURE FEE

Individual room reservation must be confirmed and guaranteed by the attendee at the applicable group room rate (plus applicable taxes) with either a credit card at time of booking or a deposit of one (1) night's room charge, within 21 days of booking. If the reservation is booked within 21 days of arrival, a credit card guarantee is required.
