1 On 08-08-07, Bob Josea of Department of Fish and Game received a report of a possible streambed violation.  
 2 The reporting party was Mark Dwyer. Dwyer reported his neighbor Ken Teague had altered the creek and  
 3 built a gazebo in the middle of the stream channel.  
 4  
 5 On 08-15-07, I spoke with Josea. He told me what Mark Dwyer had told him. I told Josea I would check it  
 6 out.  
 7  
 8 At approximately 1200 hours, I drove to 4874 Rainbow Trail in Pollock Pines. I did not observe a large  
 9 project or anything else. I was flagged down by Ken Teague. He asked me if I was looking for him. I told him  
 10 yes. I told Teague I had received a complaint that he had diverted the stream or ditch in front of his home. I  
 11 followed Teague to his property at 4874 Rainbow Trail. He showed me the work he had done along the  
 12 stream channel. I took three photographs of the work (see attached photos). I observed no violations of the  
 13 Fish and Game Code. Teague told me he had a car port recently built on the north end of his home and also  
 14 had a gazebo constructed out in front of the home. He told me he was working with the County Building  
 15 Department to secure the proper permits. The creek and or run off ditch was not disturbed and or altered. The  
 16 gazebo appeared to be built above the high water line of the creek.  
 17  
 18 Later in the afternoon, I had a lengthy, sometimes heated discussion with Mark Dwyer (the reporting party). I  
 19 told Dwyer I observed no violations of the Fish and Game Code. He did not want to hear what I told him. I  
 20 told him I would do a little follow up and talk to him again.  
 21  
 22 On 08-16-07 at approximately 1330 hours, Warden B. Ynclan #270 and I drove to the creek area above 4874  
 23 Rainbow Trail (Teague's address). I wanted to see if the creek / ditch looked more like a stream above  
 24 Teague's residence. What we observed was a drainage area with trees, logs and other debris in and along the  
 25 creek bed. We observed no defined stream and no riparian vegetation. While we were looking at the creek /  
 26 ditch we heard numerous shots downstream near Teague's residence. We drove down to 4874 Rainbow Trail  
 27 and made contact with Ken Teague. I asked him about the shots. Teague told us it was his neighbor Mark

28 Dwyer. Teague had a couple of workers removing dead trees on his property and an adjoining neighbor's  
29 property. Teague showed us a letter his neighbor had given to him to allow his workers to cut the trees.  
30 Warden Ynclan and I inspected the creek / drainage area. Warden Ynclan came to the same conclusion that I  
31 had. There was no violation of the Fish and Game Code and the gazebo was constructed above the high water  
32 mark of the creek / ditch /channel.
