The County of El Dorado (EDC) and the El Dorado County Employees Association, Local #1 (Local #1) agree that, due to the significant gap between the salary of the Senior Public Defender Investigator and the Public Defender Investigator classifications, an equity adjustment should be granted to the employees in the Public Defender Investigator classification. Therefore, effective the first day of the first payroll period following approval by the Board of Supervisors, Pay Period 17, beginning August 2, 2008, the wage rate for the classification of Public Defender Investigator shall be increased by 43.79%.
