OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, salaries for classifications included in Sheriff’s Management, Deputy Sheriff, Sergeant, and Sheriff’s Clerks are determined by Section 504 of the El Dorado County Charter; and

WHEREAS, classes of Community Services Officer, Investigator (D.A.), Sr. Investigator (D.A.), Sr. Investigator (Public Defender), Sheriff, and specified Sheriff’s management, clerical and related support classes are entitled to commensurate increases per Salary and Benefits Resolution Section 704, Resolution #227-99, and Memorandum Of Understanding; and

WHEREAS, Human Resources, in accordance with the stipulations of Section 504 of the El Dorado County Charter, has made the necessary comparisons and calculations for the purpose of salary adjustments; and

WHEREAS, the County has notified employee representatives of the indicated salary adjustments;

THEREFORE, BE IT RESOLVED, that this resolution shall establish the following salary ranges for covered classes, to become effective January 5, 2008.
