



RESOLUTION NO. 209-2015
OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO
SOUTH TAHOE REFUSE CO., INC.
AREA "B"
SCHEDULE OF RATES

WHEREAS, a public hearing was held on December 15, 2015, for the purpose of adjusting solid waste collection rates within the franchise area of South Tahoe Refuse, Area "B" (formerly American River Disposal Service).

WHEREAS, The South Tahoe Refuse, Area "B", solid waste collection rates shall have a four percent (4%) increase effective January 1, 2016.


NOW, THEREFORE, be it resolved that effective January 1, 2016, the following rates are adjusted upward 4% for the collection of solid waste within the South Tahoe Refuse Co., Inc., Area "B" franchise area:


