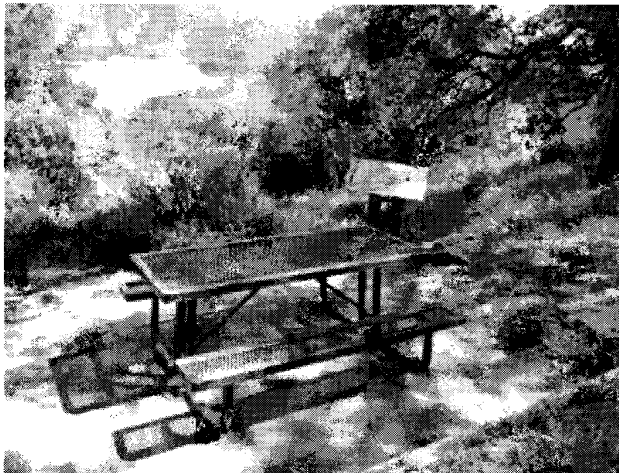

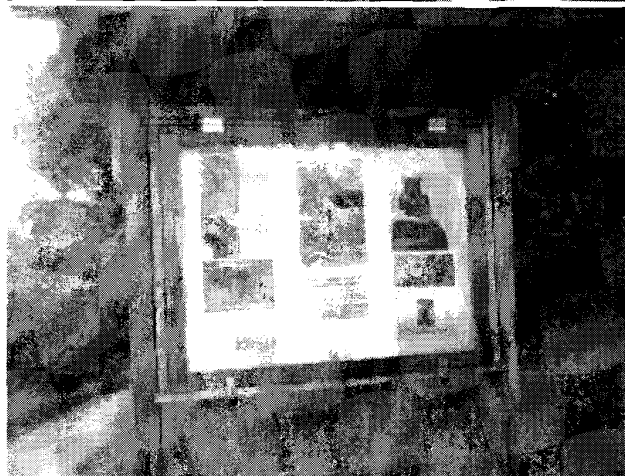

Dear El Dorado County Board of Supervisors,

In 2013, the American River Conservancy purchased approximately 1,000 acres of the El Dorado Ranch (Phase 1A) on the Main Fork Cosumnes River immediately west of Highway 49. Now they now have the opportunity to purchase an adjoining 1,080 acres of the El Dorado Ranch (Phase 1B) for \$4,995,000. ARC has able to secure funding sources for the full purchase price except for the last \$120,000.

I am writing this email in support of American River Conservancy's request for the Board of Supervisors to allocate \$120,000 from the County's "Oak Woodland Preservation Account" to complete this purchase acquisition of the El Dorado Ranch (Phase 1B).

The public would benefit from this transaction. If the sales transaction is finalized ARC will be able to preserve land, and create a public trail system park within the upper Cosumnes River east of the Sacramento line similar to the popular pubic trails of the Cronan Ranch along the South Fork of the American River. I believe such a park will be a treasured asset for El Dorado County residents and visitors.
